AMENDMENT 1

to the

MASTER SOLUTION PURCHASE AND SERVICES AGREEMENT

between

DOMINION VOTING SYSTEMS, INC.

and

THE SECRETARY OF STATE OF THE STATE OF GEORGIA

WHEREAS, the Secretary of State of the State of Georgia ("State") and Dominion Voting Systems, Inc. ("Contractor") have entered into a Master Solution Purchase and Services Agreement dated July 29, 2019 ("Agreement");

WHEREAS, State and Contractor have agreed to further modify the Agreement by changing certain terms and conditions;

NOW, THEREFORE, in consideration of the foregoing, and for other good and valuable consideration, receipt of which is hereby acknowledged, the parties hereto agree as follows:

- 1. <u>Incorporation of Recitals</u>. The above recitals are true and correct and incorporated herein by this reference as if fully set forth.
- 2. <u>Section 10.1.</u> The State and Contractor agree to delete the original Section 10.1 of the Agreement in its entirety and replace it with the following new Section 10.1. As of the Effective Date of this Amendment 1, the following amounts have been paid by the State: Section 10.1.1 \$44,967,752.40; Section 10.1.2 \$1,500.000.00; Section 10.1.8 (a) \$5,631,740.00; Section 10.1.8 (b) \$7,317.330.00; Section 10.1.8 (c) \$22,332,161.60.
- 10.1 <u>Payments</u>. As further provided in Contractor's fee proposal delivered by Contractor, accepted by State prior to execution of this Agreement, and attached hereto as <u>Exhibit G</u> (the "Fee Schedule"), and subject to the other terms and conditions of this Agreement, in consideration of Contractor's agreement to provide the Solution to State, deliver necessary documentation, train State Personnel, and render related services in accordance with this Agreement, Contractor shall be entitled to be paid as follows (each a "Milestone Payment" unless otherwise noted):
 - 10.1.1 \$44,967,752.40 on the Effective Date, inclusive of initial implementation and training and initial Equipment costs.
 - 10.1.2 \$1,500,000.00 for training and implementation upon certification of the November 2019 Election.
 - 10.1.3 \$4,386,020.40 for remaining costs for training and implementation upon Certification of the March 2020 Presidential Preference Primary Election.
 - 10.1.4 \$1,500,000.00 for final training and implementation and hold back upon Certification of the November 2020 Election.

- 10.1.5 \$834,673.35 upon Final Acceptance of election management system hardware and software to the State.
- 10.1.6 \$3,310,268.00 upon Final Acceptance of ImageCast Central scanners hardware and software for absentee/mail ballot voting.
- 10.1.7 \$1,045,000.00 upon Final Acceptance of Mobile Ballot Printing system.
- 10.1.8 The following items will be invoiced on a monthly basis upon unit Final Acceptance by the State:
 - (a) Electronic Pollbook hardware and software at \$708.93/unit for a cost of \$5,671,440.00 for the first 8,000 units, and \$1,580.73/unit for a cost of \$1,097,029.00 on remaining 694 units for a total cost of \$6,768,469.00.
 - (b) ImageCast Precinct scanners hardware and software at \$2,330.36/unit for a cost of \$8,156,260.00 for the first 3,500 units, and \$5,278.33/unit for a cost of \$1,583,500 on the remaining 300 units for a total cost of \$9,739,760.00
 - (c) ImageCast X BMD hardware and software at \$735.53/unit* on the first 30,050 units, and \$3,816.40/unit on the remaining 3,500 units for a total cost of \$35,460,089.50 (* "\$735.53/unit" reflects the reduction from the milestone payment equaling \$44,967,752.40 for initial implementation and ICX BMD cost).
- 10.1.9 The remaining System costs equal to \$24,273,467.50 (or 18.14% of the total Agreement value) shall be further discounted by \$1,941,877.40 for a final payment of \$22,331,590.10 (or 16.69% of the total Agreement value), which will be paid on July 1, 2020. However, the State, in its sole discretion, has an option to pay the remaining costs \$24,273,467.50 in annual payments over nine years. This will consist of eight annual payments equaling \$2,697,052.00 starting July 1, 2020 through July 1, 2027 and a final payment of \$2,697,051.50 on July 1, 2028. The discounted amount of \$1,941,877.40 will no longer apply if the State chooses to exercise the annual payment option. The annual payment option must be exercised by the State no later than June 30, 2020.
- 10.1.10 Equipment Charges. The price for State Entity ordered Equipment, as contemplated by the Fee Schedule, shall be set out in each applicable Solution Order (the "Equipment Charges"). Contractor shall deliver an invoice for the relevant Equipment Charges to the State Entity following State's completion of Acceptance Testing. Notwithstanding anything contained herein to the contrary the parties acknowledge and agree that purchases of new models of Equipment released by Contractor shall be made available to the State Entities at the same price as the Equipment purchased as part of the Solution Order. Contractor shall continue to support the version of the Equipment then in use by the State Entities, including ensuring that such Equipment is supported by the Software.

- 10.1.11 <u>T&M Rates</u>. Except as otherwise set forth in the Fee Schedule, this Agreement does not contemplate, and Contractor shall not be entitled to, payment for any of its work, overhead, or expenses on a time and materials basis.
- **3.** Exhibit G. The State and Contractor agree to delete the original Exhibit G of the Agreement in its entirety and replace it with the new Exhibit G attached hereto to this Amendment 1.
- **4.** All Other Terms. All other terms and provisions of the Agreement shall remain in full force and effect.


