
Pollbook signatures uploaded after Election Day, batches of 10

Elected Officials

 Elected officials don't believe there are election issues in KY. They assume it is just national.

Sec of State

- SOS poisons local clerks with misinformation to prevent records requests
- SOS uses
 mouthpiece
 media to insult
 anyone fighting
 for election truth.

Data Access

 Data has been very difficult to obtain. To date, we still don't have complete voter data for all 120 counties.

Oversight Obstruction

- Primary candidate petitions to count ballots against the machine tapes have met strong resistance.
- Clerks trained how to deny records requests
