






Voting Systems



Dominion Voting System





- Unauthorized access into a server room by a badged employee – Files deleted? Overwritten? Archived?
- Same shared password? Was the password, "password"?

Do the machines vote for us at times?



 Candace, a resident of Avondale, indicated that she did not vote. However, Maricopa County records show that she voted by mail-in ballot



- Austin, a resident of Queen Creek indicated that he dropped off his ballot at the polling location, however Maricopa County has his vote recorded as early in person.
- Further research also shows that his **PEVL status was not** active, so he should not have received a ballot.

- Hanna and her husband, residents of Queen Creek indicated that they both voted in person on election day, however Maricopa County has their vote recorded as early in person.
- In addition, they each received two ballots and are not on PEVL.



 Jesus, a resident of Avondale, voted by mail-in ballot, however Maricopa County records has no vote recorded.



- Kristine, a resident of Avondale, voted by mail-in ballot, however Maricopa County records has no vote recorded.
- Further research indicates the following:
- She was in miliary. Ballot was mailed early because of UOCAVA status and sent to old address. Her registration address was changed on 12/20 and military address removed.

- Anonymous, resident of Arizona, indicated that Elizabeth, who is registered at her address, moved to Texas 20 years ago. Every election cycle Linda asks to have Elizabeth removed, but they continue to receive a ballot for her.
- Further research shows that Elizabeth's **PEVL** has never been active and no ballots should ever have been mailed to her. She has also been registered in Texas since 2001.

 From Phoenix, Brenda and her husband never received their mail-in ballots, even though their PEVL status is active.



- One of our canvassers attempted to visit 1 KAKA VILLAGE GILA BEND AZ 85337. There is no structure at this address. Online searches in Google, Google Earth and tax-based databases confirm that this address does not exist. Kaka Village however is in the Hickiwan District on the Reservation in Pima County, AZ and this address is listed as a polling location in past Maricopa County Elections literature.
- Data shows that 57 people were on the voting rolls at the time of the 2020 election. The following information was found:
- 13 people have been deactivated and reactivated multiple times throughout their voter history.
- 16 people have no voter history at all at least one going back to 1993 and another going back to 1996; six have been deactivated
- None of these voters voted in 2008.
- 16 were mailed a mail-in ballot, but their vote is recorded as in-person.
- 12 were deactivated 1/21, four of which only voted in 2020 with no other voting history.
- 17 were mailed a ballot, however they are not on PEVL.
- Most of these people are still registered.

- An unnamed resident of Tolleson, stated that all five residents received ballots and mailed them in. Two of the five have no vote recorded.
- Fortino also stated that he received a bunch of extra ballots, but couldn't even guess at how many or the names on them. He burned them.

- Kathy, a resident of Phoenix, indicated that Denise was is registered at her address, was the previous owner of the home.
- Further research indicates the following:
- Denise moved to Texas in 2006. She has also been registered there since 2006
- She is still active on the Arizona Voter Rolls

- Carlos, a resident of El Mirage indicated that he received a mail-in ballot, but did not request it.
- Further research indicates the following:
- Carlos is active on PEVL, though he did not request to be active.
- Carlos is registered twice with two different Voter ID numbers

- Gloria from Chandler, passed away prior to the 2020 election. A relative of Gloria's shared this and also stated that everyone in the family voted for Trump (and hated Biden's border policies). When asked if Gloria also voted for Trump, he looked at the canvasser as if they were crazy and said "No, she died!"
- Maricopa County has a mail-in vote recorded for her. (sure hope it was for Trump)
- Her registration is still active.

ONE DAY ONE VOTE

- Voter ID Required
 Hand Count Paper Ballot
 - Smaller Precinct Polling Locations
 - No Machines
 - No Mail-In/Absentee Ballots
 - Except for Military, Disabled and those who can not be at the Polling Station
 - Results Right Away

What is wrong with this legislation?

- A voter may not receive or vote a ballot unless the voter presents a valid state-issued identification
- Except for absentee ballots as prescribed by section 16-541:10(a) all voting shall occur on election day only



What is wrong with this legislation?

- All ballots shall be cast in person by the voter at the voter's election precinct polling place.
- All ballots shall be counted by hand, canvassed and results made within twentyfour hours after the polls are closed.

What is wrong with this legislation? The board of supervisors may not establish an election precinct that contains more than 1,500 registered voters on the date the election precinct's boundaries are established.

What is wrong with this legislation?

The board of supervisors or other officer in charge of elections shall not allow the use of electronic or other tabulating equipment and all counting shall be done by hand.



What is wrong with this legislation? The board of supervisors, county recorder and officer in charge of elections may not require that a voter, a board worker or any other person wear a facial mask, be vaccinated or tested for a virus as a condition of entering a polling place or other voting/tabulating location.

Roadblock

- Our legislators said they did not have the votes!
- However, the smart thing to do would have been to put it up for vote so WE THE PEOPLE could see exactly who the NO VOTES were.



Victory

Maricopa County had the country's largest forensic audit. Counterfeit ballots were discovered BUT the legislators did not allow the information in the report.

Canvassing revealed 299K potentially illegal votes BUT the legislators did not allow it in the report
