Hi Alaina,

I had a question about your request for \$6,000 of CARES Act funds for ballots, envelopes, inserts, and mailing costs. Federal funds cannot supplant county funds, so it cannot cover the ballot and mailing costs you otherwise would have incurred. However, federal funds can cover any increase in costs such as:

- Additional ballots being sent to voters on the do-not-mail list;
- Printing an additional insert for coronavirus information;
- Any reprinting costs incurred in order to include coronavirus information on envelopes or inserts;
- Additional mailing costs if they are higher than normal election years (e.g., more spoiled ballots than usual).

Let me know if we need to modify your request for \$6,000 by the end of this week. Thanks!
