2022 Primary Election Risk-limiting Audit Discrepancy Report

The attached report represents the discrepancies reported by audit boards during the 2022 Primary Election. It is generated using the Colorado Risk-limiting Audit Software with annotations by the Voting Systems team in the Colorado Secretary of State's office. For the original version of the report used, see the report labeled CVR to audit board interpretation comparison (Round 2) on the Audit Center of the Secretary of State's website.

This report contains the following columns:

- county_name The county that audited the ballot on which the discrepancy occurred
- contest name The contest on the ballot that had the discrepancy
- imprinted_id This is the unique number assigned to each ballot. In the Democracy Suite voting system the imprinted_id is a three-part number (X-XXX-XXX). The first part represents the tabulator the ballot was tabulated on. The second part represents the batch number of that tabulator. The third part represents the ballot position within the batch. The ClearVote system uses a similar notation, with the addition of a notation for the election added. Rows are also colored or not to show discrepancies that are on the same ballot, but in different contests.
- choice_per_voting_computer The choice that was tabulated by the voting system according to the cast vote record
- audit board selection The choice that was reported by the audit board
- audit_reason Denotes a targeted race on a ballot by listing the type of audit reason (state or county)
- ➤ Discrepancy Reason The Voting Systems team determination on the most probable reason for the discrepancy.

After the audit has concluded, counties are required to send images of each ballot that had a discrepancy (regardless of it being a targeted contest or not). The Voting Systems team at the Secretary of State's office then compares the images to reports and uses any information given by the county to try to determine the most likely reason for the discrepancy. In the 2022 Primary Election the following reasons were most likely responsible for all discrepancies:

- ➤ Audit Board Error The audit board entered incorrect information which did not accurately represent the voter markings.
- ➤ Wrong ballot The audit board retrieved a different ballot than the ballot required by the RLA software, and therefore entered in incorrect choices

- ➤ Voting System Limitation A narrow circumstance where the voting system tabulates a vote for a selection the voter corrected because the voter did not choose a different choice in the contest. (A different selection would result in an overvote and the system would out-stack the ballot for adjudication by election judges.) In this case, the voting system is incapable of discerning true voter intent.
- Ambiguous Voter Intent The voter marked their ballot in a way that is not easy to interpret. Because of this ambiguity the adjudication judges and audit board disagreed about how the voter's intent should be interpreted.
- ➤ Voter Mistake The voter marked their ballot in a way that was contrary to on-ballot instructions that resulted in the voting system incorrectly determining voter intent. For example, the voter marked certain races outside of the target areas of certain choices.
- Adjudication Error When the ballot was presented for adjudication during tabulation, the bipartisan team of adjudication judges did not correctly adjudicate the ballot according to the Secretary of State's Voter Intent Guide.
- ➤ CDOS Instructions Deficiency—The ClearVote voting system tabulates write-in votes in the CVR differently from the Democracy Suite system. This difference had the potential to cause a misreport in the Colorado RLA Software. Steps were given to the two counties that use ClearVote to mitigate this issue. However, the mitigation technique did not cover all potential scenarios which resulted in reported discrepancies by the software. Write-in votes were tabulated correctly by the voting system.

The reasons for the discrepancies are an interpretation by the Voting Systems team based on the ballot image as well as some supporting data found in the audit reports or provided by county staff. It is not definitive. Likewise, this list of types of discrepancies is not exhaustive, but are the only types that were found by the Voting Systems team in this election.
