


Reason for Hope



- Election Integrity Committees in the House and Senate have provided a platform to educate both the legislators and the public on election violations and findings.
- House committee has opened an exploratory investigation into Runbeck Election Services, requesting documents and video to determine RES role and the need to restrict or eliminate it.
- Both Chambers passed Senate Concurrent Resolution 1037
- RINO Ken Bennett's dangerous legislation to codify fraud was blocked by Rep. Alex Kolodin
- Rep. Legislators passed unprecedented election integrity bills. Even though they knew they would be vetoed, they pressed on.

More Reason for Hope

- SCR-1037 requires all machines meet DoD security standards

Reason for Hope: Phantom Voter Analysis



- Election Fairness Institute has launched VRA in AZ
- Triangulate CVR, Property Tax Record & Voter Registration
- Identify properties that are not legally permitted
- Identify irregularities 100 RV's at a 850 SqFt SFR



- Identify RV's at MFR's with no apartment or unit number
- Publish suspicious PROPERTIES for government, parties & media
- File for injunctive relief to force curing of phantom ballots early
