Roadblocks

Obstruction

- Open Records requests are being denied, ignored, and phony and inaccurate answers given
- ES&S is in Omaha, NE and has tremendous political power and financial resources

Public Awareness

- Getting messaging out, our media ignores the issue completely - Massive censorship
- Not enough media attention to prove that ES&S is just as bad as Dominion
- All major newspapers and news outlets are owned by same company

Legislature

- Centralization of state senator power into one body politic Our unicameral- the opposition needs only 17 senators to block everything required legislatively to cure our election issues
- Few state senators see the massive potential for fraud---they support incumbents regardless of job performance
- No bravery
- Gov. Ricketts used "dark money" to ensure the Uniparty candidate was (s)elected

SoS

- Bought and paid for by RNC/DNC (Uniparty) and National Assn of Secretaries of State to maintain current (s)election system. Usurpation of legislative power over elections.
- He refuses to meet with actual experts, only listens to ES&S; we have looked at data and do not believe he won the May 2022 primary against our candidate
- Claims the machines aren't connected to the internet and won't address the dirty voter rolls that are always online

Grassroots Coordination

- Nebraska's geography makes it difficult to accomplish tasks. It's challenging for rural parts of the state to meet.
- People are afraid to step out and tackle the problem. There is a lack of self-motivation to educate themselves.
- There is a large monetary and cultural gap between urban and rural areas resulting in power imbalance.

Legislative Efforts

- Weak efforts to placate constituents
