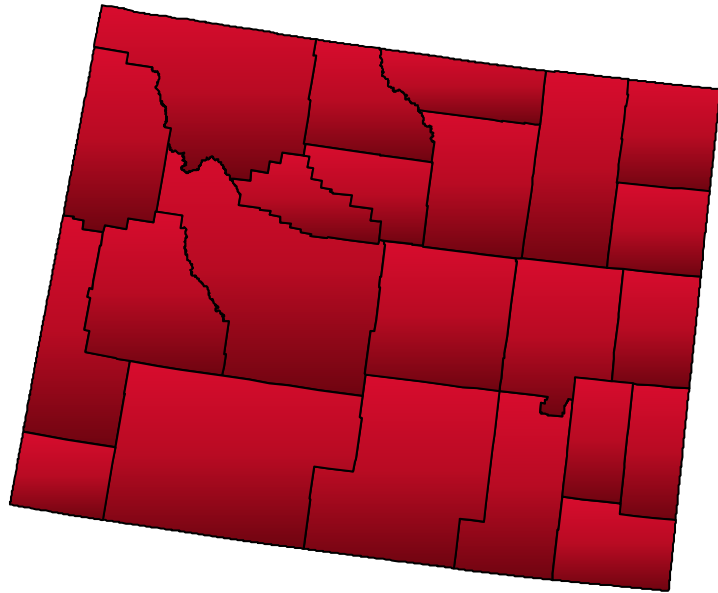

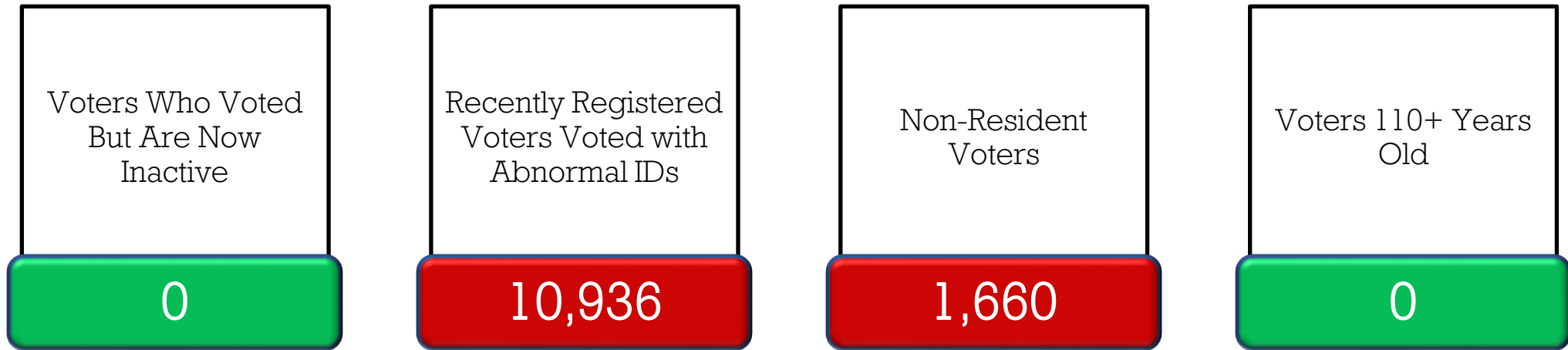

A-10 Be able to import electronically from the Secretary of State and counties in an agreed-upon format that contains, at a minimum, the following data:

- a. Full candidate name;*
- b. Candidate sequence, title and text of ballot questions, and voting language options;*
- c. Office name;*
- d. Contest name, including candidate name in case of retention contest;*
- e. Maximum number to vote for each office;*
- f. Party affiliation;*
- g. Number of eligible registered voters at the precinct; and*
- h. Number of active registered voters at the precinct.*

ES&S RESPONSE

Our solution features robust import and export capabilities that would facilitate the exchange of data between voter registration systems and our EMS. We have worked with multiple customers to integrate with statewide systems and have considerable experience in this area. For example, in Michigan, Mississippi, and Utah, we recently coordinated with those states to allow for (1) the importing of election data (contests, candidates, etc.) from their statewide system into Electionware, and (2) the exporting of results data from our EMS in the format required by their statewide system. Ultimately these efforts have resulted in increased efficiency, elimination of redundant data entry, and significantly increased the speed of results reporting statewide. Each element such as contests, candidates, precincts and parties, offers 10 Additional Text fields for any needed uses. This allows you to track each of the data described, plus many more options.

ES&S RESPONSE

The DS450 is able to write Cast Vote Records to an election media device during operation, and an Admin user can “lock” the ability to view results – both on the tabulator and the EMS software. This allows users to scan ballots and perform ballot review (adjudication) without concern of prematurely viewing election results.

The DS450 secures all data ports behind clear plastic lockable and sealable access doors to protect access and allow election officials to easily detect unauthorized access. All critical hardware components can be locked and sealed, as well.

The DS450 provides access codes that allow access for operator and administrative roles. Access code protection is configurable to protect all operations of the applications.

The DS450 provides options for both real-time printed and electronic logging of all activity performed, with the ability to reprint logs on demand or export electronic logs for complete review.

In addition, all user actions (such as administrative selections and open and close poll events), whether successful or failed, are written to the audit log. Only the DS450

Why are there business addresses listed across Wyoming to mail Absentee Ballots to when the Voter's residence of those addresses have nothing to do with that business?

Example: Sheridan Business that the registered voter does not work at or own. This is not a mail center, so mail would be simply destroyed ... yet the Absentee ballot was sent to this address and votes were received from Big Horn, Buffalo and Afton. Several more examples like this

Kai Schon

- The person who has stopped all FOIA requests to verify if our elections were legally run in our State
- Wyoming signed a contract with ES&S in March 2020. At that time, State Election Director, Kai Schon, told the told the Buckrail in Jackson Hole, “Each ballot will be printed on paper—always creating an audit trail that can be used to confirm the accuracy of every single vote.” Now, over two years later, nobody yet has been allowed to audit the printed ballots. What good is an audit trail that is shielded from audit--whether by elected officials or citizens?

WYO SOS Buchanan and RHINO State Legislators

- SOS Buchanan has repeatedly insists Wyoming's elections are clean and has put roadblock after roadblock in the way of citizens and election integrity groups trying to present evidence of election irregularities or call for audits. SOS Buchanan has been unwilling to let the voting machines be examined and gone around the state with ES&S officials disparaging Mike Lindell and the work he has done. Only 3 out of 60 Wyoming legislators were willing to sign onto Arizona State Senator Wendy Rogers' letter calling for forensic audits in all states where evidence of election irregularities and illegalities exist

Openings

Legislative Efforts

- Voter ID Laws Passed
- State Statute in place requiring the voting rolls in each county to be cleaned up annually
- Only 9 out of 23 counties in Wyoming continue to use drop boxes

Cross-Over Voting

- Liz Cheney used illegal material to educate non-Republicans to change parties for the 2022 Primary to vote on the Republican Ballot
- Current estimates are 11,000-13,000 voters will change parties to vote Republican and it is assumed they will switch back after the 2022 Primary

Actions Sought

- Liz Cheney illegally used trademark material on all campaign literature.
- Current efforts to reprimand Liz is underway.
