

## Reason for Hope



### Florida

- **Some minor election integrity improvements related to Florida Senate Bill 7050**
- **Voter roll maintenance now performed every year instead of every other year**
- **Incrementally more action required to maintain clean voter rolls**
- **Florida Republican Assembly passed an election integrity state resolution**

## Reason for Hope: Legislative Success



### Florida

- **SB7050 contains some minor election integrity improvements, it also provisions that remove transparency and public visibility into the elections process. These provisions seem to be far more damaging than the new improvements the bill provides.**
  - **Blocks Floridians and or citizen groups' election oversight...**
  - **Requires the Secretary of State to provide mandatory formal signature matching training to specified persons...**
  - **Requires that third-party voter registration organizations provide to the Division of Elections the general election cycle for which they are registering persons to vote, beginning on a certain date**
  - **Gives Gov. Ron DeSantis the "all-clear" to run for president while serving as governor.**



I want to bring to your attention that our State Voter Integrity Taskforce has identified a total of 408,848 Voter Registrations statewide containing no valid mailing for either the residential or mail address which are inconsistent with Florida Statutes and the Division of Elections Legal Advisories.

**Out of the 408,848 total state-wide, Bay County has 2,374 registrants that were identified and require your immediate attention to determine what actions need to be taken to bring these addresses into compliance.**

Please note, the data reflects active voter registrants with residential or mail addresses that the US Postal Services deem "Undeliverable As Addressed" (UAA). Please see attached CSV file and applicable Florida Statutes that apply: (97.041(1)(a)3; 98.015(12); 98.045(1); 98.065; 98.075; 101.62; DE 18-09.

**Please provide your feedback and remedy on or BEFORE April 30, 2023.**

The Florida Republican Assembly (FRA) is a steadfast watchdog that is committed to election integrity regardless of party affiliation. We identify REAL issues as well as provide REAL solutions. **RE: SUBJECT: RESPONSE TO PUBLIC REMARKS AND CALL FOR ACCOUNTABILITY AND INTEGRITY.**

Dear Mr. Hayes,

We are deeply disturbed by the recent derogatory and defamatory comments you posted about the [Florida Republican Assembly \(FRA\)](#) on the [Lake County Supervisor of Elections website](#). Using an official government platform for partisan communication is not only highly inappropriate but calls into question the integrity of your office.

Despite our numerous attempts to contact your office to discuss significant discrepancies in voter data, your response has been one of dismissal and disparagement. Our findings, which include over 408,848 invalid addresses and 222,537 registered voters residing out of state, warrant serious attention. Specific to Lake County, there are 5,792 active voters with bad addresses and 4,980 active voters who live out of state. In addition, we have found 276 Lake County voters that NCOA has shown as having moved out of state prior to September 2022, that still voted in the November 2022 election. As a constitutional officer your primary responsibility is to maintain the sanctity of the electoral process. Instead, your actions have demonstrated poor judgment and disregard for the role you are entrusted with. The FRA is a Judco-Christian organization dedicated to seeking TRUTH as well as upholding election integrity and transparency. We cannot overlook the gravity of the situation or the potential implications this may have on fair and just elections.

Considering the egregious nature of your conduct, coupled with the failure to engage constructively on critical issues affecting electoral integrity, we firmly believe that it is in the best interest of Lake County and all Florida voters for you to step down from your position.

The FRA calls for your immediate resignation. It is time for responsible and ethical leadership that will work earnestly to ensure the integrity and fairness of our electoral system.

THE FLORIDA REPUBLICAN ASSEMBLY, IN ALIGNMENT WITH OUR COMMITMENT TO VOTER INTEGRITY, AND ADHERENCE TO THE UNITED STATES CONSTITUTION CALLS FOR THE ENACTMENT OF LEGISLATION THAT PROHIBITS ELECTRONIC VOTING SYSTEMS IN THE STATE OF FLORIDA AND THAT REINSTATES THE USE OF PAPER BALLOTS AND MANUAL HAND COUNTS.

WHEREAS, ensuring an accurate count of votes cast by eligible voters is essential for the functioning of a Republic;

WHEREAS, the Federal Help America Vote Act has established the Election Assistance Commission to set standards for election system certification and provides funding to states adopting qualified systems;

WHEREAS, Florida has received \$148,633,048.00 in funding under Section 251 of this Act;

WHEREAS, the Election Assistance Commission's latest certification standards (VVSG 2.0) issued on February 10, 2021, states that devices with internet connections are not permissible as part of the voting system and cannot be certified;

WHEREAS, Florida Law 101.015 (4)(a) mandates the Florida Department of State to establish minimum security standards for voting systems;

WHEREAS, Florida Statute 101.5605 (4) allows the Department of State to reexamine any previously approved voting system to update its certification;

WHEREAS, Florida Statute 101.015 (7) requires the development of methods to gauge public opinion regarding voting systems;

WHEREAS, the two currently approved systems, are not only cost-prohibitive but have become controversial and face credibility issues due to the companies' lack of transparency regarding financials and ownership;

WHEREAS, several countries have ceased using internet-connected voting systems to mitigate the risk of cyberattacks and fraud, and have successfully transitioned back to manual counting systems;

WHEREAS, elected officials in Florida have outsourced the election process to a single vendor without sufficient oversight, transparency, or proper authorization;

WHEREAS, a significant number of Floridians have expressed a loss of trust in the current electronic voting system and are calling for the ban of such systems, advocating for the adoption of paper ballots similar to the French voting system.

WHEREAS, within the United States it is incumbent that only United States citizens with valid identification maybe permitted to vote. Therefore, the Florida Republican Assembly demands inclusion of such law within our Florida statutes.

THEREFORE, BE IT RESOLVED, the Florida Republican Assembly, through a unanimous vote by its directors, and fifteen (15) chapter President's support Governor DeSantis and Florida State Legislators in passing legislation that prohibits electronic voting systems in Florida. We strongly urge the adoption of paper ballots and manual counting systems prior to 2024 elections.
