



Voter Roll Growth vs Population Growth All Counties




- Large increase in the voter rolls just prior to elections and large decreases right after. How many of the voters that were in the surge are also being removed immediately after?
- Removals only after general elections?
- Overall registration growth appears to be backed by the actual voting population growth (seen in the high correlation)


 Voter roll growth among the counties moved in concert with each other. Each county had different voting population growth, but saw the same patter of growth and decline in the voter rolls


National Change of Address (NCOA)

Voters Filed Permanent Change in Mailing Address but Still Registered in Boulder County




- 10,325 active and inactive voters who filed permanent changes of mailing address out of Boulder, Larimer, and Weld counties, but are still registered in their old county
- If someone files a permanent change of mailing address to another county, then they would have to pick up their mail daily in the other county. Safe to assume they moved to the new county

Non-Military Voters — Interstate Moves All Counties




- 43,373 voters who filed permanent changes of mailing address out of Boulder, Larimer, and Weld counties, but are still registered in their old county
- If someone files a permanent change of mailing address to another state, then they would have to pick up their mail daily in the other state. Safe to assume they moved to the new county

Percent of Changed Mailing Addresses by County



Inactive Voters Reactivated



Inactive Voters and Ballots



- When clerks are notified of voters who move out of state or mail is returned undeliverable, they are marked inactive and won't receive a ballot
- 1. Although the above statement is true, clerks rely on getting NCOA data from the SoS (who gets it from ERIC). We have verified instances where clerks never received an NCOA notice for a voter, so they weren't marked inactive, and their address was not updated
- 2. Changing a voter status from inactive to active is relatively trivial thanks to the wonders of the internet (and the SoS page where you can do it online)



Reactivating Inactive Voters



 There are many checks and balances required to reactivate online. You need to know the personal information of voters to do so



Inactive Voters Reactivated





- 2020 saw many inactive voters reactivated in time for the general election
- Subsequent years have seen additional voters re-actived from the inactive pool creating a cumulative effect



Quick Recap

- 1. Counties had major insertions of voters right before general elections and major deletions immediately after. How many of the voters added to the rolls right before an election are subsequently removed right after the election?
- 2. Growth in overseas UOCAVA voters were highly correlated with military UOCAVA voters, suggesting a potential cloning of military voters
- 3. Over 53,000 voters filed a permanent change of their mailing address out of their county, but are still registered in their old county
 - 1. Upwards of almost 7.4% of certain counties rolls are filled with voters who have filed a permanent change of their mailing address out of their county of record
- 4. Counties have seen high numbers of their inactive voters reactivated, especially in 2020
 - 1. Given the ease of re-activating a registration online, recent data breaches could provide the means of reactivating voters as needed




Voter Roll Growth vs Population Growth Boulder County

Voter Roll Growth vs Population Growth Larimer County






UOCAVA Voters Boulder County

- High correlation suggests that overseas voters may be cloned from military voters




UOCAVA Voters Larimer County
