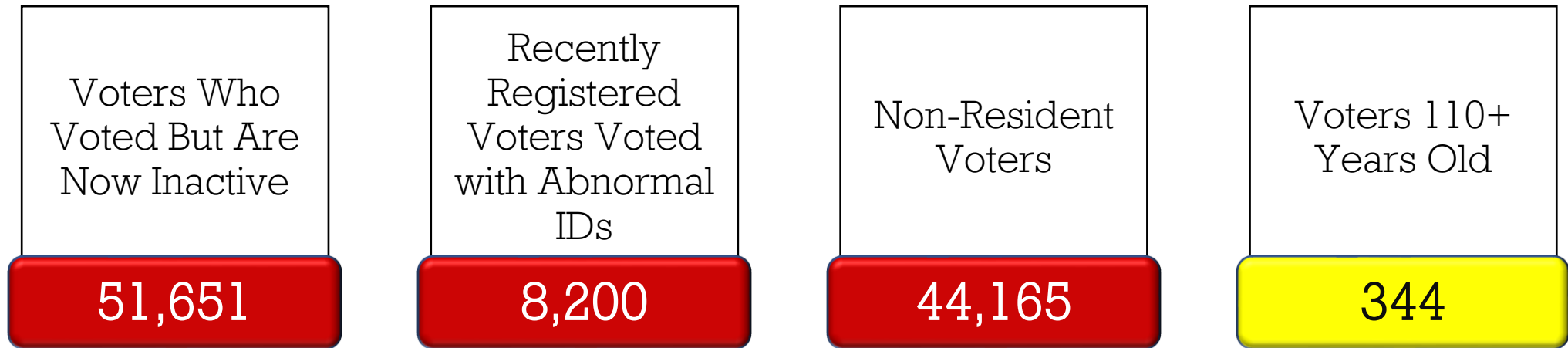

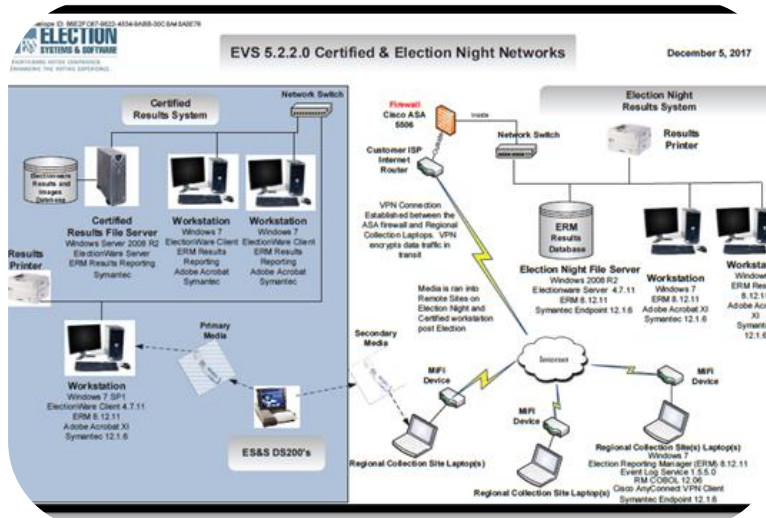

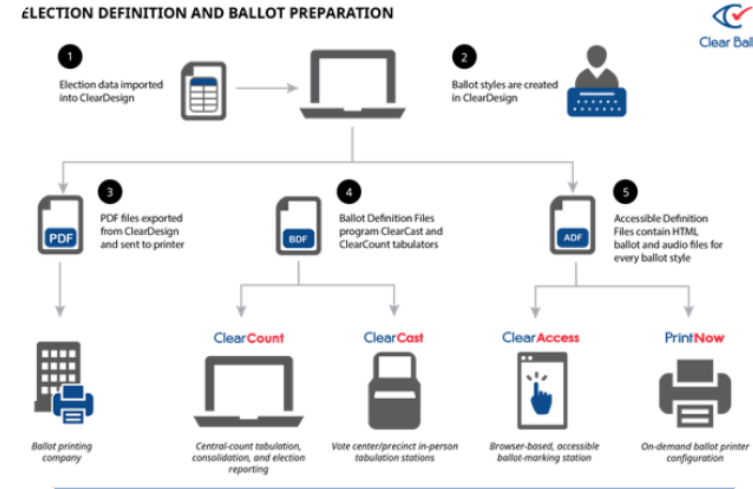

Explain This

- 2020 – Presidential General Election
 - 106,000 voters made inactive after voting in 2020
 - 146,989 Active voters that should be inactive
 - ~5,000 “twins” voted sharing same address (1928 – 1985)
 - 498 voters over 100 on Election Day, oldest is 117
 - 12,492 Voters voted after NCOA move date
 - Ballot Box Video Surveillance video deleted
 - 4,786 County Registration Dates older than State Registration Dates
 - Was told state date is original registration, county date is latest change
 - Registered after Voted 11/3/2020
 - 818 registered after 11/13/2020
 - 679 Registered after 1/1/2021
 - State Registration Dates showing future dates (2/9/2108)
 - 21 Counties and Balto. City received Grant Money “Zuckbucks” from CTCL
 - RICO case filed



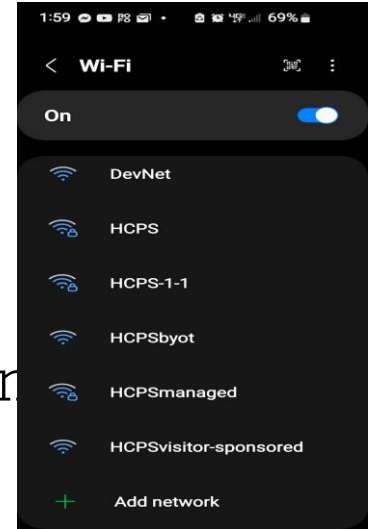

Explain This

- 2021 – Annapolis City General Election
 - Ballots mailed to ALL registered voters
 - Election Day votes: 1,937
 - Total mail-in votes: 7,889
 - Candidates leading or close on Election Day and lost by landslide after mail-in count
 - Candidate 1: Up by 86 on Election Day, lost by 219
 - Candidate 2: Down by 6 on Election Day, lost by 409
 - Candidate 3: Up by 105 on Election Day, lost by 280
 - 1,367 less registered voters reported on Election Day than on formal roles
 - Incomplete explanation provided by Board of Elections

Explain This

- 2022 – Gubernatorial Primary Election
 - Unexplained Wi-Fi networks on election day
 - Were not present the day before
 - Anne Arundel Co. Active and Inactive voter registration removed during “Election Month”
 - Harford County candidate winning by a large margin on election night (232) but lost during mail-in ballot count (11)
 - Election certified 27 days after (8/15) the election (7/19)
 - Montgomery County identify 102 uncounted ballots
 - Frederick County recount due to mail-in ballot discrepancy
 - Were all county ballots counted and certified?
 - Non-citizens registered to vote via Motor Vehicle Administration

Roadblocks

Apathy

- Ownership: Not having anyone in an official capacity caring enough to investigate our concerns or take a holistic view of the anomalies we found in the data and processes
- Motivation: Not having enough volunteers to keep things moving forward
- Acceptance: Candidates are not challenging results.

Centralized System

- Maryland is very centralized.
- County changes must go through State Board Elections (SBE).
- Linda Lamone:
 - Appointed for life as Director of State Board of Elections
 - Board of Advisors to the EAC for the National Association of State Election Directors
 - Was on the founding board of ERIC

Censorship

- Press blackout
- Text censorship
- Locked out of FB

Data Preservation

- 2020 election data preservation
- Inquiry to State's Prosecutor – Deleted video - Pending response

Legal Counsel

- Affordable, knowledgeable legal counsel willing to take case

Obstruction

- Overall corruption of elected officials - none want to look into the problems or solve them
- Compelling a government agency to hold SBE accountable for violating state and federal laws
- Getting reasonable explanations from SBE for anomalies found in their data and our canvassing efforts

Victories

Large following

- 2,700 on Facebook
- 1,000 on Telegram
- 8,000+ mailing list via email

Canvassing

- Baltimore, Montgomery and Harford Counties were canvassed door to door
 - All with press releases
- Our core group members are all doers and very dedicated to election integrity efforts
