Roadblocks

Destruction of Records

- MSP stole machines under investigation by Sheriffs
- MI Bureau of Elections ordered destruction of election records
- Antrim County Clerk ordered destruction of records

Lawlessness

- SoS issued unlawful election instructions
- AG threatens to disbar lawyers investigating election
- Local clerk removed from Election Oversight by SoS for Questioning Public Accuracy Test

Media Bias

- Persistent 1-sided narrative in favor of election officials complicity with election fraud

Legislature

- Denial of election fraud
- Republican legislature advised on policy options by staff that now works for Democrats
- Constitutional right to an audit denied by courts

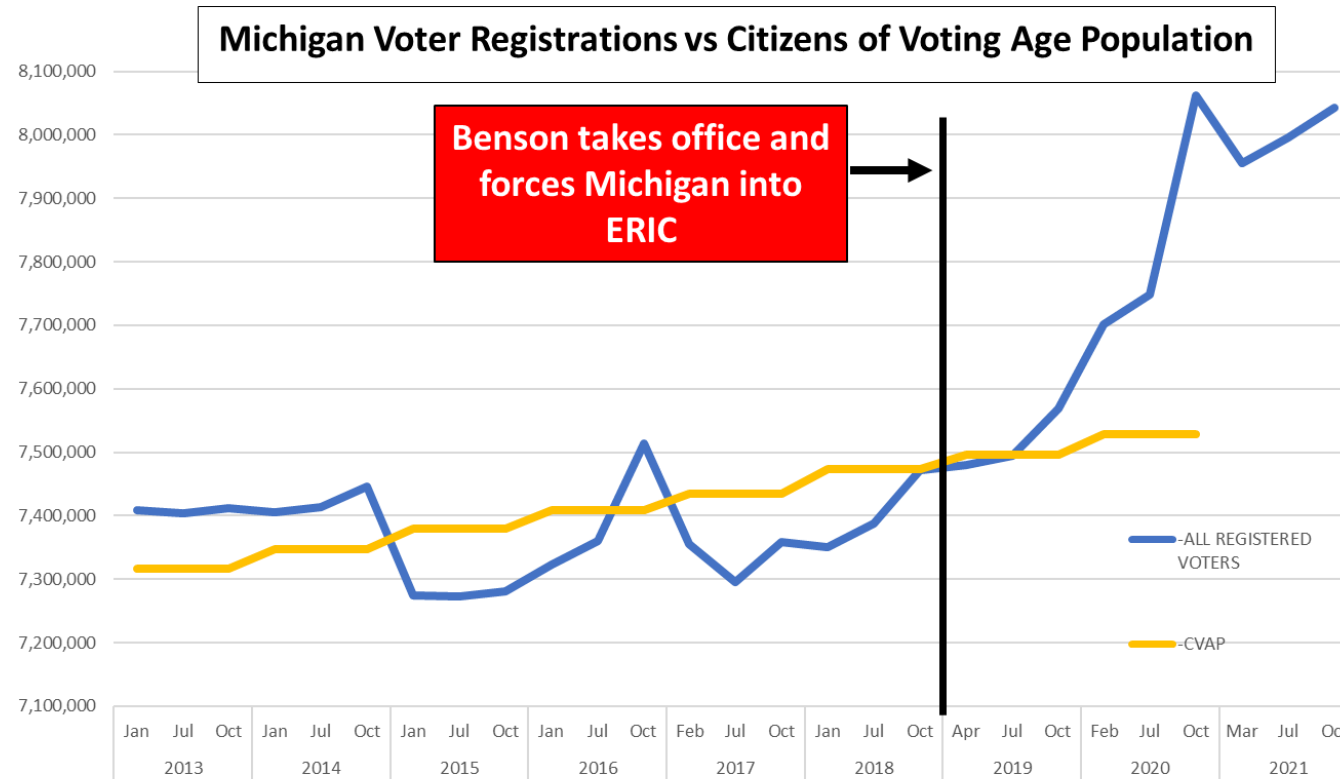
Lack of Remedy

- Only a handful of lawyers available to address hundreds of unlawful actions
- FOIA requests blocked
- Legal avenues are restricted or non-existent

Voter File Integrity

- More voter registrations than eligible voters and more added every day
- Voter history data is continuously changing
- Official records indicate an over vote in 2020 election

Over-Registration Problem



- 1 million more registered voters than drivers licenses
- 500k more registered voters than CVAP – 7+%
- 475k registered voters with National Change of Address issues
- Registrations continue to grow daily

Victories

SecureMIVote Petition Drive

- Over 400,000 signatures gathered to promote VoterID, drop box reforms and 3rd party funding

Data Analysis

- Data collected and analyzed on a monthly basis
- Developing a DB to track addresses and registrations

Poll Workers

- Over 3,100 poll workers recruited for 2022 election so far

Canvassing

- Statewide canvassing efforts yielded between 4% and 44% 2020 voter roll anomaly rates in an election reportedly decided by a 2.78% margin

Election Fraud Investigations

- Reports on statewide voter file inaccuracies
- TCF Timeline report provides detailed timeline on 2020 fraud
- Ballot trafficking evidence

Ballot Challenges

- First in nation to issue statewide ballot challenges before the election (Over 22K)
