



Claims about Dominion Systems being linked to widespread fraud in the 2020 Presidential Election are COMPLETELY false.

U.S. government intelligence agencies have conclusively affirmed that no voting system deleted, lost or changed votes in the 2020 presidential election. A declassified [intelligence report](#) released by the Office of the Director of National Intelligence, found "no indications that any foreign actor attempted to alter any technical aspect of the voting process." The U.S. Department of Justice and the Department of Homeland Security also [released a report](#) stating there is "no evidence" that foreign governments or other actors interfered with the elections, and claims about foreign governments manipulating or owning election infrastructure used in the 2020 elections are "not credible." The U.S. Cybersecurity and Infrastructure Security Agency said it was the [most secure election](#) in U.S. history, while former Attorney General William Barr confirmed [no evidence of widespread fraud](#). Other DOJ officials [described](#) a conspiracy theory with voting machines as "pure insanity."

On Voting System Security

All Dominion voting systems are tested and certified by federal and/or state election authorities according to law.

- ✓ Voting systems are designed and certified by the U.S. government to be closed systems that do not rely on Internet connectivity for use.
- ✓ Dominion builds its own software code. It does NOT use code from other companies.
- ✓ All votes are cast and counted in the U.S. by local election officials. This data is not sent outside the U.S.
- ✓ Remote access to voting machines does not exist.
- ✓ Voting system security measures are based on strong technical, chain of custody, and physical security controls.
- ✓ Pre-election testing and post-election canvassing allow election officials to identify and resolve discrepancies with unofficial results, validate vote counts, and ensure the accuracy of vote totals.
- ✓ Dominion voting systems produce paper ballots and paper records, as well as digital ballot images, for 100% reliable audits and recounts.
- ✓ State and local officials run elections, NOT Dominion. Voters and bipartisan political party observers are meant to witness every step of the election process.
- ✓ Dominion has a coordinated vulnerability program for handling findings from good faith security researchers.
