

# Explain This

- June 7, 2022 Primary Governor and US Senate race election night reporting results virtually the same in each county in SD. Appears to be 75/25 algorithm numbers.
- Election night reporting stopped at 1:00 in the morning and then resumed at 8:30 a.m. the next day in several counties.
- 4,733 Absentee Mail Votes from 514 America's Way, Box Elder, SD with one day turnaround in 2020.
- 92% of homes canvassed with five or more registered voters had voter roll discrepancies.
- Lifetime registered republican voters discovered voter registration party affiliation changed without their consent or knowledge.

## Roadblocks

#### Secretary of State

- Won't answer questions
- Denied FOIA requests for election information
- Buried security scan of SOS website
- Will not advise county auditors anymore; refers them to State's Attorney
- In 2020, purchased ES&S machines for all counties that were hand counting ballots.

#### **County Auditors**

- Destruction of drop box videos
- Deny FOIA requests for Machine logs, CVR's and ES&S Contracts
- •Ask ES&S how to respond to the FOIA requests
- •Charging \$1/page and up to \$90/hour to copy documents requested by citizens.

## State's Attorneys

- •Coordinated statewide effort to block FOIA requests with the same response letter in every county
- •State Bar Association President is the lawyer retained to defend the counties against the citizens lawsuit for public information

### Legislators

- Difficult to get stronger election integrity bills passed.
- Blocked bills to remove dead voters, clean up voter rolls, and audits.

## County

- Will not add election issues to agenda
- •Will not meet with SD Canvassing
- •Deny their responsibility for election issues
- Refuse to take action against machines or drop boxes.

## Terrible State Election Laws

- Very vague and open to interpretation.
- Residency is sold on the internet with voting rights.
- Affidavit allowed if no state ID.
- NO Post Election review or audit.
- •SD receives an "F" from Heritage Foundation

## Mail Forwarding Services

- Mail forwarding services are a big industry in the state, which makes canvassing very difficult. We have lots of phantom voters from these businesses, which have grown 4X in the last three years.
- •11,757 voters from one address

#### Voter Rolls

- Voter rolls hosted online by SOS website.
- •Website is not secure
- •Very outdated voter rolls. Must be thrown out and start over.
- Hacked voter rolls

## Victories

## Legislative Efforts

- Passed a ban on Zuckerbucks.
- Freedom Caucus letter to AG and Governor requesting ban on drop boxes and to give the CVR's to the people.
- Draft legislation for next session.

## Law Enforcement Investigations

 Investigation opened into mail forwarding service and residency fraud. Affidavits presented of stolen votes, lost votes, dead voters, voter roll manipulation, and more. Fictitious voter registrations being reviewed.

## Party Victories

- A major grassroots movement of patriots who were elected as precinct committee people elected a new Secretary of State as our Republican nominee at the State Convention. She promises to reform the election system.
- New Auditor Candidate for Minnehaha Co.

## **Grassroots Activism**

- Grassroots movement who are also sharing truth about election integrity.
- Networking and recruiting people to start working in their county to pressure their auditor, commissioners, and legislators.
- Recent podcasts, radio shows, and news articles to get the word out.

## Lawsuit

- Lawsuit currently filed against the counties for denying CVR's and Machine logs for the 2020 election, and the June 7, 2022 primary election.
- Preservation of 2020 election records.
- Letters of intent to sue against surety bonds sent to auditors who continue to use illegal drop boxes.
