Thank you for submitting your narrative and a revised reimbursement request form. I have a question regarding the \$2,976.40 reimbursement request for the local paper ads. The invoices you provided add up to \$2,177.88:

- 1/29/2020 Invoice: \$214.50
- 5/27/2020 Invoice: \$181.75
- 07/06/2020 Invoice: \$375.00 (for the flyer)
- 06/15/2020 Invoice: \$156.75
- 06/24/2020 Invoice: \$1,249.88

Here are some other issues with the request:

- The 01/29/2020 Invoice will not be able to be reimbursed, as it was before the coronavirus was declared a national emergency.

I just wanted to confirm the following costs with you before we issue the reimbursement:

- \$375.00 for flyers
- \$181.75 for Times-News Publishing invoice #34563 (05/27/2020)
- \$455.86 for additional office supplies
- \$712.20 for additional election workers
- \$650.48 for postage meter
- \$1,100.00 for 4 stall voting booth
- \$2,293.00 for ballot box
- \$1,698.66 for computers
