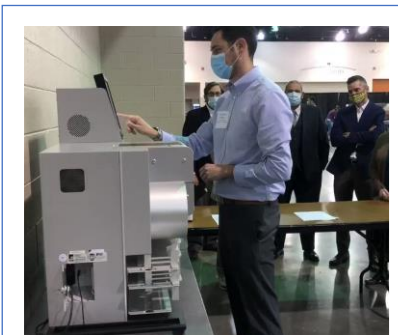

Montana 2020 general election results on the Secretary of State's website continued to be updated through September 10, 2021.



Montana Secretary of State, Christi Jacobsen, in her first run for office receives more votes than President Trump.



Dana Corson, Montana's Director of Elections & Voters Services in SoS office, admits on 11-3-20 that there is an area of ES&S voting machines that they cannot verify or access.



Marijuana passes in 2020 within 2500 votes of Trump. On losing side, state with highest gun ownership per household in the country gets more votes than any candidate.

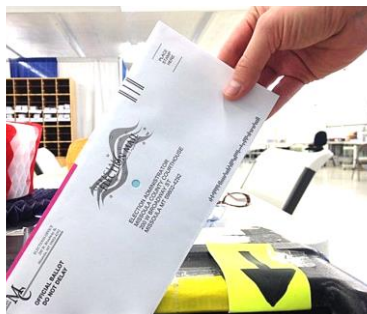

Montana #1 in Trump states for CTCL funds per capita received (43% higher than #2 state Kentucky), contrary to Montana law (MCA 13-1-302) which protects Montana elections from such outside funds.



Citizens find 4,592 votes were certified in Missoula County without corresponding signature envelopes with one color stripe in 31 boxes in Missoula County. Republican Party, 15 months later, recounts envelopes with 2 colors in 33 boxes and finds only 71.



Of 752,538 registered voters in Montana's 2020 general election, estimated 303,749 or 40% have invalid addresses.



More than 200 birthdays and registration dates that are impossible. Example: 119 year old voters and voters registered in the 1800s.
How could these votes have been certified?

Roadblocks

Carbon County

- 4 warranty seals broken by ES&S tech in Spring 2020 to make “altitude adjustments.” Seals were never replaced.

Citizens Targeted

- Sheriff’s office advised public to report citizen canvassers
- County election clerk published article warning public not to answer questions from canvassers

Citizen FOIAs

- Dozens of citizen FOIA’s ignored across the state from county offices, and from the Governor, Lt. Gov., AG, & Auditor

Secretary of State

- Violated MCA 13-1-109 by not providing names of all people who voted in the 2020 general election.
- Violated MCA 13-1-302 by advising election clerks to apply for CTCL funds.

Victories

Citizen Efforts

- Canvassing
- Meetings w/ County Commissioners re: illegal CTCL funds, machines, election process

2020 Results Questioned

- 6 county GOPs declare Biden was not winner in 2020
- 4 counties asked that SoS resign from NASS

Legislative Efforts

- 4 election integrity bills passed in 2021, 2 under injunction by judge
- Paid ballot harvesting temporarily still legal in MT

Public Education

- Hosting movie nights for Rigged, and 2000 Mules
- Holding educational mtgs
- Appearing on talk radio
- Educational materials
