# **Explain This**




DEMTECH pollbooks invalid certification. KNOWiNK test results omitted from public records.



VFAF Canvassing results indicate ~5.6% of absentee ballots were invalid. Also, PWC results currently under investigation by AG but no explanation as to why.



Significant and blatant errors in official data records: 380,000 turnout discrepancy; Changing of public archive records after-the-fact; many many more.







## Roadblocks

### **Public Perception**

- Many not aware big problems in VA.
- Belief that the DC area (NOVA) is blue, and that's just how it is.
- Belief that Youngkin's win was due to typical election activities (GOTV and poll watchers, etc) This discounts efforts of citizen "Digital Poll Watching", data analysis, public pressure on Electoral Boards, etc.
- Lack of understanding +/or political will by legislators.

#### Data

- Expensive and restrictive access to data. >\$16K for a single full statewide data pull, not available to general citizens.
- Elections held every year and machines reset.
- Voter rolls need cleanup.
- Years of IT infrastructure negligence.
  - Process, administration and maintenance failures.
  - Technically impossible to completely reconstruct election events from data.

#### **Election Code**

- Machines are required by the VA code. Virginia is a Dillon Rule state. Localities cannot override General Assembly.
- \*New\* same day registration requirement.
- Longest early voting period in the country
- No ID requirement
- Ballot harvesting is legal
- Elections now less secure than 2020. Intentional weakening of integrity efforts by opposition after Youngkin win.

### Legal Support

- Attorneys not willing to take El cases despite agreeing they are "very good cases" regarding election issues, FOIA denials, procedures.
- Multiple meetings with new AG and Commissioner of Elections. No interest in "looking backward".
- Election Officers fired for pointing out security issues and gaps.
- Threats harassment and intimidation to concerned citizens.





## **Victories**

### **Technology Development**

- Development of multiple custom canvassing apps by VFA and VFAF.
- Development of (EPEC) web based poll watcher reporting tools, with configurable notification to Poll Watching team leads.
- Also TAP citizen election reporting tool.
- Multiple teams now working to uncover and deep diving on data and process issues, automation of issue detection and reporting.

### Discrepancies Discovered

- Discovery of 380,000 ballot discrepancy in reported 2020 turnout numbers.
- Worked with multiple teams including VFA, TVP, VFAF, Draza Smith and others to track the Virginia 2021 election in real time.
- VFA Identified 9 races that were possibly flipped at the CAP on 2021 election night.
- Discovery of ~3K ballots misattributed due to pollbook issues in 2021.
- Identified 429 "Vanishing Voters" from 2021 DAL records
- ... (much more)

#### Media and Education

- VFA Election Defender Podcast. Raising awareness of issues and gaining traction.
- EPEC now formed and will publish real time issue tracking and analysis during upcoming 2022 General
- Multiple groups working to organize poll watcher and election officer trainings

### Process / Legal

- Helped to stop Mark Elias
   Fairfax Lawsuit to extend
   deadline to receive
   Absentee ballots (2021) and
   quickly show data evidence
   that suit was unfounded.
- Stopped election officers taking pollbooks home to update in Fairfax
- multiple org's are in the process of trying to file TRO's to preserve records
- Won lawsuit forcing Fairfax to release chain of custody documentation for dropboxes (Ned Jones / TVP)
