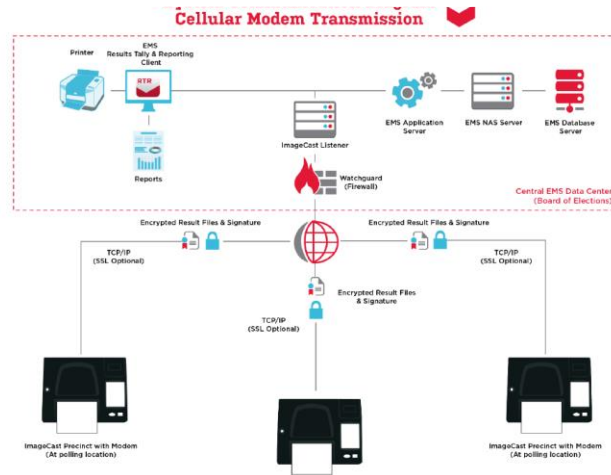

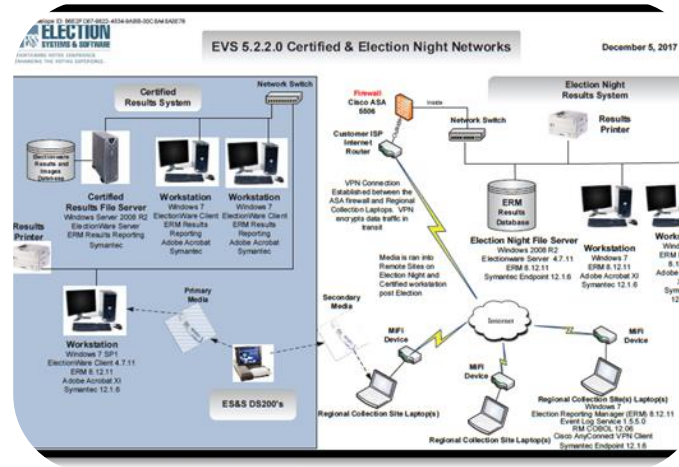

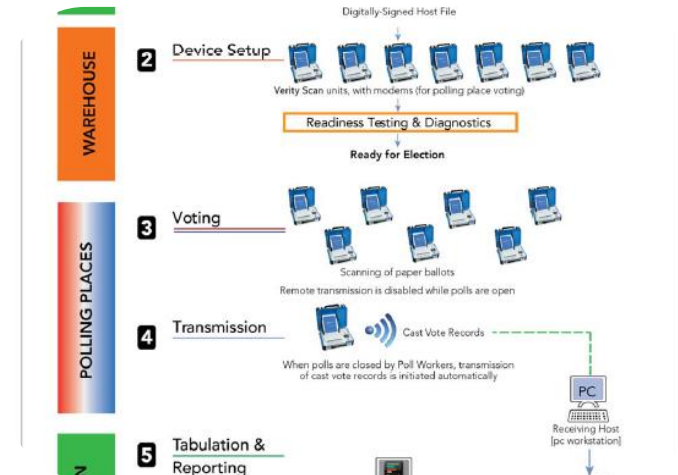

Roadblocks

Lack of Transparency

- The system created for elections in California is not accountable to We the People.
- The system is corrupted by the laws that allow for poor accountability and transparency.
- Many elections officials lack 100% cooperation with the citizens of their county.
- Many charge exorbitant fees to acquire information for citizens to be able to review.
- Very few counties offer easily accessible Cast Vote Records.
- Many times, We the People do not get the whole story and must file Public Records Act requests to get it.
- Most limit available data on Voter Drop Boxes and how the CTCL grant monies were used.

Inactive voters

- We can get access to active voters but not to the inactive voter roll list or how it is managed.
- Acquiring all county CVRs would help to analyze the activities of Inactive Voters.

Thing we don't know!

- [CCR 19081\(c\)](#): requires the ROV send out mailers to inactive voters. Are they doing it?
- [NVRA 42 USC 1973gg-6 SEC 8\(c\)](#): Removing inactive voters for not voting in 2 Federal Election cycles, NCOA notices, and non-responsive voters.

Legal resources

- Attorney General, District Attorneys, and County Sheriffs do not have a strong understanding of election law, some not even knowing what a voter roll is.
- Developing legal strategies are critical to our success when our elected officials running our elections no longer are willing to answer to We the People.
- Lawsuits, grand jury filings, interpretation of laws and codes, are all requirements to find and remove any violations and/or corruption in our election system.

Victories

Voter Rolls

- Obtained several versions of statewide and county voter rolls.
- Created a data analysis tool for quickly reviewing millions of records for anomalies and patterns.
- Obtained county CVRs and shared with data pattern experts.
- Dozens of groups to bring accountability back to our elections.

Ballot Drop Boxes

- Video surveillance patterns for ballot drop boxes.
- Evidentiary package for lack of security with drop boxes.
- Alternative security measures.
- Acquired proposal to add video surveillance to all drop boxes.
- Discovered BoxLock program managed by company in Atlanta, GA.

Duplicates Discovered

- Duplicates found on the voter history file.
- As many as 7 votes cast for one single voter in 2020 election.
- 20,697 voters cast 21,324 Duplicate Votes in the 2020 election.
- County and State election officials have the data to investigate this and stop this.

Out of State Residents Discovered

- Found out-of-state residents that received VBM ballots for the 2022 primary election.
- Affidavits secured and working to acquire more.
- Defined the 3 factors that are consistent among all the Out of State residents receiving ballots for CA elections.

Partnerships

- Established partnerships with other state and national level grassroots organizations and individuals.
- Defining the expertise and areas of impact for each group to reduce inefficiencies and double work.

Canvassing

- Have developed a successful canvassing team and training plan for CA.
- Currently canvassing multiple counties and will have more trained for the 2022 mid-term election.
- Acquired affidavits.
- Defined anomalies and areas to focus our efforts.
