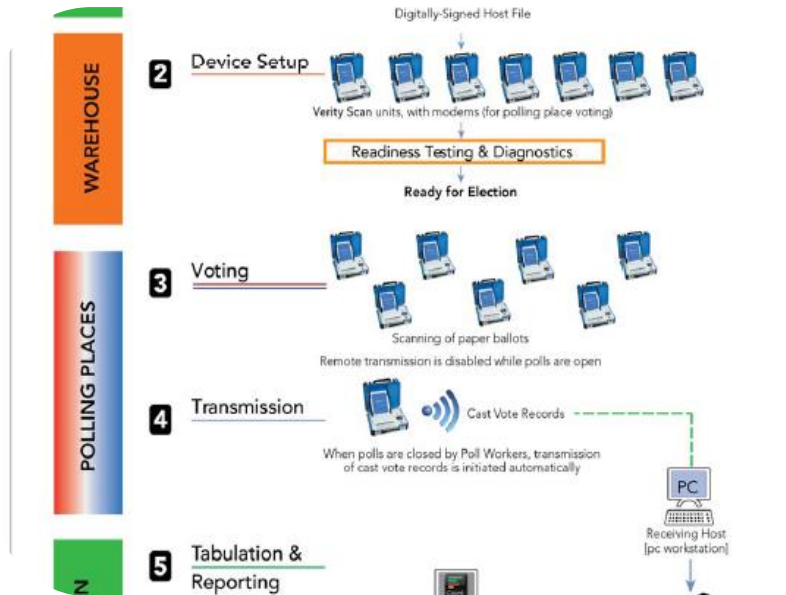

- 65,000 Voter ID cards returned undeliverable in OK County June 2022

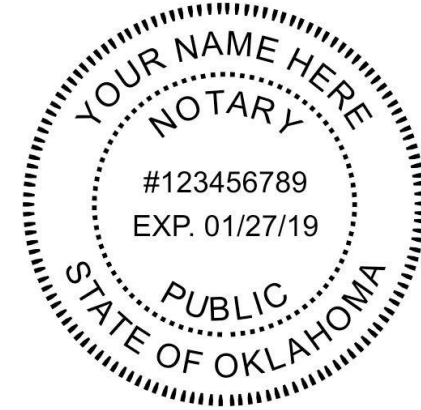
Explain This



- Time Traveling Voter voted in Feb election and was simultaneously given credit for voting in the Apr election long before ballots were ever printed



- Tennessee resident voter discovered by canvassers, never registered to vote in OK but has been listed as an active OK voter since 2012.



- Absentee ballot affidavits missing notary stamp are allowed.

Roadblocks

Election Secretaries

- All Election Secretaries are appointed not elected.
- Inconsistent Training.
- Fraud is well hidden making legislators reluctant to act.
- State Election board claims there is no CVR available.
- 3 member boards are a problem when County Election Board Secretary is a bully.
- No Checks and balances.

Legal Issues

- Most election integrity bills were held up by the OK Senate.
- Sheriffs lack knowledge and/or willingness to exercise their authority.
- Existing laws were designed to prevent audits and enable fraud.
- Hidden agendas, fear of persecution keep people silent.
- FOIAs unanswered.

Non-Uniform Election Procedures

- Wide discrepancy from county to county as to election procedures and we have had minimal success getting issues addressed.
- Intimidation, Incompetence, and No transparency.
- Eye witness violations go unreported due to intimidation.

ERIC

- Oklahoma voted in 2020 to join ERIC and approve the use of e-pollbooks once funded.
- Election Secretaries are paid based on the number of active voters in their county, therefore they have minimal desire to clean voter rolls.
- Attempt made in 2022 to meet all the ERIC member requirements thwarted



Victories

Canvassing

- Speaking with legislators and other groups about the results of our canvassing has put pressure on the State to fix voter registration and to follow laws with some success.

Legislation

- Proposed legislature setting the conditions to meet ERIC's requirements has been rejected.
- Legislation was passed in 2022 to require additional proof of identity to request absentee ballots online.
- Thwarted attempt to give drivers licenses to illegal aliens.
