Roadblocks

State Office of Elections/Lack of Transparency

- Inability to obtain election records
- FOIA denials:
 - Nonexistent ballot images
 - Vanished CVRs
 - Audit Logs refused
 - Exorbitant fees
 - Won't give historical voter rolls

Legal Resources

- No lawyer(s) to assist with FOIA appeals & injunction to preserve election records

Democrats & RINOs in Power

- Democrat Trifecta
- Hawaii has the most lopsided State Legislature in the US
- Hawaii has 76 legislators, 5 are Republicans, and all 5 will not address election corruption
- Chief Officer of Elections is appointed, not elected

Lack of Awareness/Citizen Apathy

- General political apathy of citizens (challenging to recruit volunteers)
- Lack of public awareness of Hawaii's election corruption
- Hawaii residents like the convenience of universal mail voting so it will be a challenge to eliminate it, but election reform MUST occur

Victories

Lawsuits/FOIA Appeals

- ATVHI has submitted FOIA denial appeals
- working on a pro se injunction to preserve election records
