The Salt Lake County Clerk's Office received your emailed GRAMA request on November 30, 2021. Your request stated:

Please see attached the documents you requested that conforms to your search.

Utah Code 20A-2-S104 allows individuals to request that their voter record is classified as withheld. Voter records classified as withheld cannot be disclosed to non-governmental agencies. Utah Code 20A-2-S104 further allows voters to request additional privacy protection if they are, or are likely to be, or reside with a person who is or is likely to be, a victim of domestic violence or dating violence. Also, a person who is, or resides with a person who is a law enforcement officer, a member of the armed forces, a public figure or protected by a protective order or a protection order may request additional privacy and protection of their records. Voter records classified as private or withheld are not released to unauthorized individuals or entities.

You may appeal Salt Lake County Council Clerk's response to this request pursuant to GRAMA §63G-2-204 & Salt Lake County Ordinance §2.82.040C by filing a written appeal within 30 calendar days of receipt of this letter to the following address:

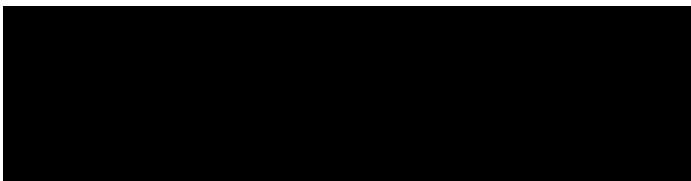
