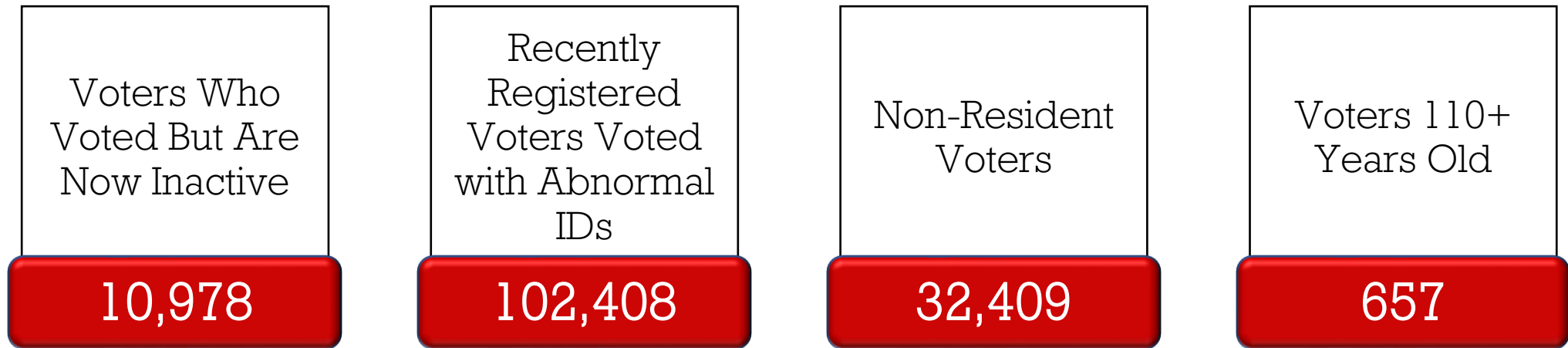

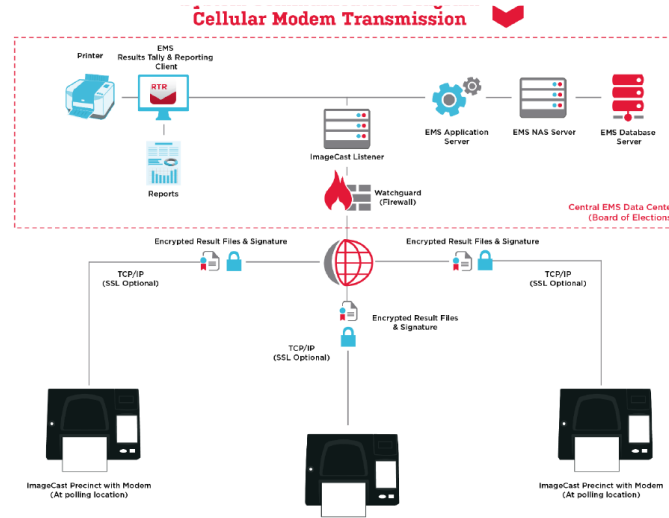

Voter Registration Anomalies

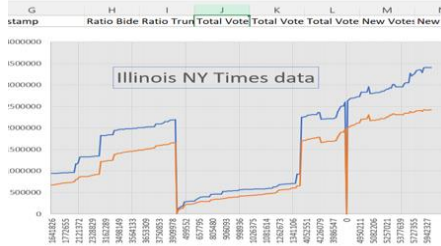

Roadblocks

State Board of Elections

- The Illinois State Board of Elections (SBE) oversee the election process in Illinois. The Secretary of State (SOS) has no input on election laws or procedures since 1970 constitutional changes.
- The SBE Board members are appointed by the politicians of the state and are not elected by the people. The SBE has a complaint process that will not hold it's self accountable.
- Multiple complaints of statutory process falls on deaf ears. To change or add state laws requires approval by the party in power.

Citizen Obstruction

- There is no method for the voters to apply or offer any change directly.
- There is no method for a citizen to challenge the election out come or process.
- Citizens have no access to obtain voter rolls

Accountability

- The Constitution (1970) has taken away or made extremely difficult any avenues of re-call or even removal for violation of oath of office.
- The Bond requirement was changed to allow that no bonds are required by many elected officials but instead a self insurance plan is in used. This allows many of the elected and non-elected officials to hold office with no ""Skin in the game"".
- The State Board of Elections are not accountable to the people... they are selected by the politicians.

Legal Assistance

- The lawyers of Illinois that have been contacted want no part of challenging the current system.
- Lack of Funds - to challenge the existing process and laws that can only be challenged in a legal system.

Lack of Publicity

- Little to no coverage of "election Integrity issues".
- Very few publishers want to take the chance of legal liability.
- Small publishers are starting to write about the movement to correct our voting systems.
- Word of mouth through the many groups in Illinois has helped to spread the information amongst the grass roots organizations.

Victories

Partnership

- Illinois Conservative Union has teamed up with Judicial Watch to fight for access to voter rolls by citizens. (on going)
- Cause of America (Illinois) is working with U.S. EIP, Illinois Freedom Alliance,
- Groups are sharing training material for Poll Watching and Election Judges..
- Over 12 Illinois Groups have come together under Illinois Fair Elections Coalition to share technical, knowledge, and personnel resources.

Grassroots Mobilization

- The victory in our state is the gathering of grassroots people into a more cohesive body. Some groups have grown to over 2000 members in which many participate in election integrity programs. Some groups organize around getting people involved in Precinct Committee engagement, Election Judge engagement, Canvassing of voter rolls, Poll Watcher engagement, Election Integrity projects, fighting Health Mandates, School Board issues and even local group meetings. Some are very specialized, and others speak to many issues
- But all are educating their members of the issues we have in our state and country.
