

DOE Personnel: Some "Light Timing Marks"?




DOE Public Counting of 2022 School Board Elections

Between pre-screen
(~6% +/-) and scan
rejects (~12% +/-)
about 18% of
"Absentee" ballots
required "Duplication"

Those are really small sets of data.

Any larger data sets that might be related?





FOIA Response 2020 General Election

47,205 ballots sent to adjudication.

If all "Absentee or Mail In".. That would be about ~20%+/- of that category.

Could items above disqualify certain parts of the system?





Roadblocks

Board of Elections Communications

- Hadn't met in 7 of 12 months. (Board Vacancies)
- No email or contact info.
- Live "phone" meetings. You have 3 minutes sir
- They may just not know

Department of Elections Communications

- Individuals in person are very helpful, professional and friendly. Happy to address common questions.
- As questions get harder and perhaps more sensitive..... Slow or no response and FOIA roadblocks.

Not Sure

People are Busy: Have Limits

- People have said they have data or reports they will send or have someone contact you....and it doesn't happen. Are you getting stonewalled?
- I look at my own limits and know I didn't follow-up on some of these so not fair to throw stones yet. Most want to help.

It's Election Season!

- •Candidates will be door knocking, making speeches, asking for support. That's an opportunity!
- •Ask them:

Where do they stand on the Machines?

What are they doing to clean up voter rolls?

Are they planning to exercise their right to "examine the ballot" (count ballots) on election night?
