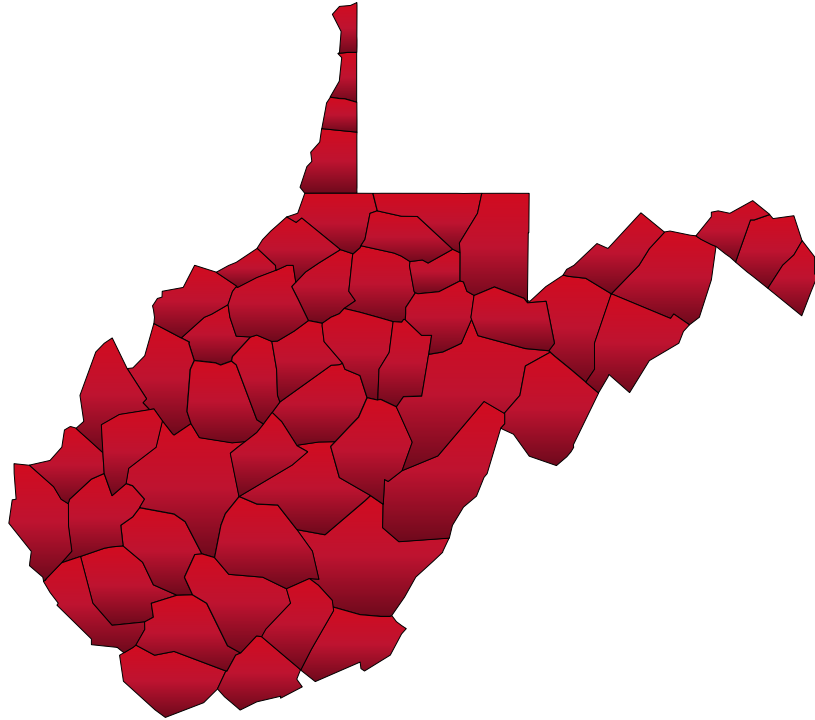

Won by 309,398 votes

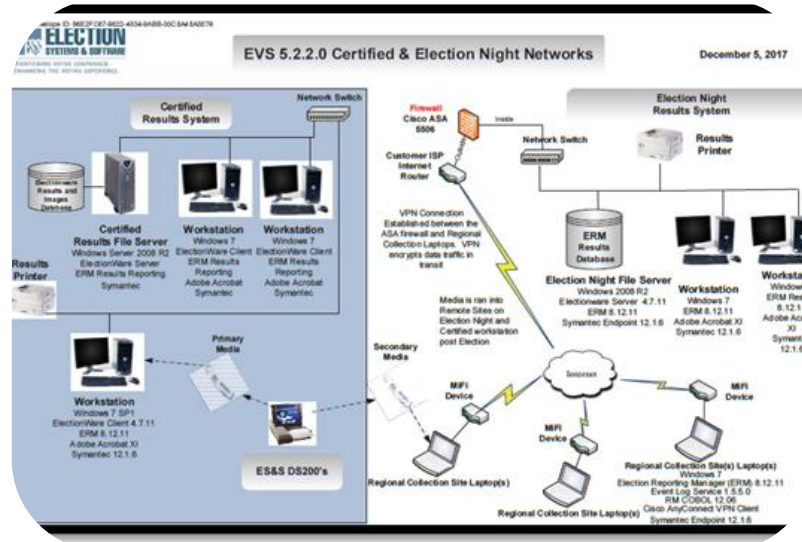
## The Truth

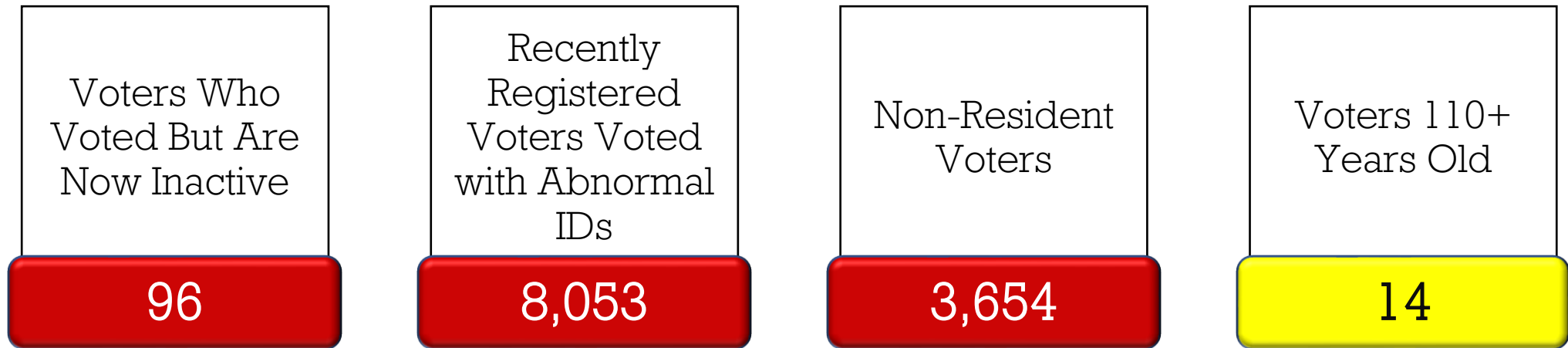

## Voter Registration Address Differences

The WV Voter Registration Process Allows for a Mailing Address that is Different from the Registration Address.

As of 2021, 238,808 registered voters have a mailing address that is different from their registration address.

## Voter Registration Short ID Numbers

The WV Voter ID numbers were Switched from a 7-Digit Number to a 9-Digit Number in 2004.

From 2004 to 2021, 77,695 Voter ID Numbers have been Assigned that are from 2-digit to 7-digit numbers.

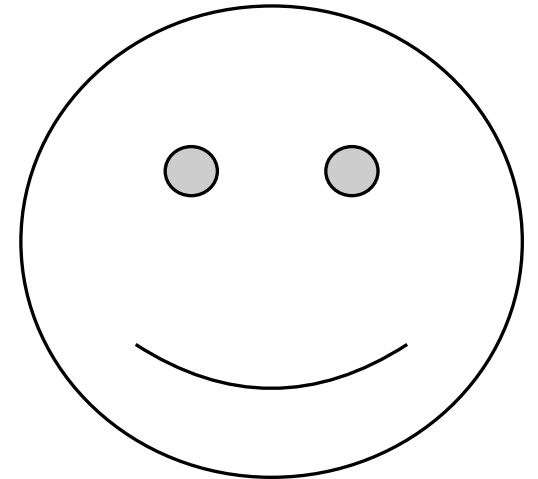
## 2020 High Voter Turnout

Ages 20, 49, 50, 55 - 73, 77 and 78 was 80% or Over

Ages 38 - 41, 43 - 48, 51 - 54, 74, 79 and 82 - 83 was 70% or Over

Ages 19, 30, 33 - 37, 42, 76, 80 - 81, and 84 was 60% or Over
