



My name is Deidre Henderson, I am the Lieutenant Governor of the State of Utah. In my role I am also the Chief Election Officer of the State and my most important job is to follow the law. Many people don't realize, though, that my Office does not run elections. We oversee them, but every election is run at the county and municipal level.

There have been a lot of accusations and inaccuracies tossed around lately, and I want to unequivocally state for the record that in Utah, we value voters just as we value the rule of law.

Article IV of the Utah Constitution is the guidepost for the way we run elections in the state. It not only guarantees voting rights to adult citizens residents of the state, but it also says that they "shall be entitled to vote in the election," and that their votes "shall be by secret ballot."

Over the past few years, our state has made methodical and deliberate improvements to election law with the aim of both increasing access to the ballot and increasing the security of elections. Policy and lawmakers have recognized that those two principles: ballot access, and election security, are not mutually exclusive principles. We can and do have both. What's more, our state has proven that election security and ballot access need not be divisive partisan points of contention. When it comes to election processes, we can all agree on the fundamental democratic principles that underpin our Republic. These include MORE voter turnout, NOT voter suppression.

In the last few years, the legislature made systemic improvements that increase our citizens' rightful access to free and fair elections. Our reforms have served as the vanguard—the model—for other states.

Some of these improvements include:

- Universal Vote by mail
- Voter Ballot tracking
- Same day voter registration

Each of these improvements comes with multiple safeguards to ensure the integrity of the process, such as public audits, signature verification, chain of custody requirements, Utah REAL ID, address validation, not connecting any elections equipment to the internet, secure drop boxes for voters who do not wish to use the US Postal Service, and a process for candidates and citizens to challenge the results of an election.

I would like to add that last year there were a total of 462 individual races throughout the state, and to my knowledge there was not a single challenge to any of those results.

That being said, we are continually learning and improving our systems and processes to make sure that we always abide by the governing principles of ballot access, election integrity, and rule of law. So far this year I have visited 21 of the 29 county clerk offices throughout Utah and I have come away from those visits, not only grateful for the public service that each of the clerks

and their staffs render on behalf of our state, but also confident that the law and our processes are being faithfully followed.

But, I have also noticed some areas that could be bolstered and improved, and I am working with Rep. Jon Hawkins and the County Clerks to propose legislation that would address additional safeguards including audits of the voter registration rolls, in-person attendance of post-election audits to provide an independent review of the process, and improvements to the controls governing ballot processing.

Weber County Clerk Ricky Hatch, who is the chair of UAC's Clerk/Auditor group will add detail to some of our proposed ideas for these additional improvements and safeguards to our elections.

In conclusion, I want to address the allegations of fraud in Utah elections. I'm extremely concerned that public officials who deliberately sow seeds of distrust in the integrity of our elections are undermining the very foundations of our constitutional republic. In America, we believe in the peaceful transfer of power. We value the fact that every citizen has the right to have their voice heard, to express their support or opposition to government leaders and policies, and that the process by which they do that is free and fair elections. In the United States, we understand that sometimes you win and sometimes you lose, and that's okay. There is always another election but let's not use baseless claims to undermine the public's faith in our election processes, because doing so is a threat to our form of government and our very freedom.

Can our system be improved? Of course it can. And it should be. But we let's not confuse "reforms" with clear attempts to suppress voters who might look and think differently than us.

We are not going to start implementing Jim Crow laws in the state of Utah

We want INCREASED voter turnout in our elections, not voter SUPPRESSION.

The ideas presented before me are not election reform, they are voter suppression. and should not be referred to as such. Let's call

- (i) the individual indicates on the form that the individual, or an individual who resides with the individual, is a victim of domestic violence or dating violence or is likely to be a victim of domestic violence or dating violence; or

- (B) a member of the armed forces, as defined in Section 20A-1-513;

Dear Representative Christiansen:

The Office of the Lieutenant Governor has received your letter of September 14, 2021 and hereby replies to your request.

You have asked for records that are classified as "private" under Utah's GRAMA statute of U.C.A. 63G-2-302(1)(j)-(m) or withheld under U.C.A. 20A-2-104. These include records such as a voter's driver license or identification card number, social security number, email address, date of birth, or phone number. In addition, voter registration records from individuals who have declared their information private or opted to have their information withheld as private are "private" under GRAMA. Except in certain situations, a governmental entity may not disclose records that are private. Accordingly, the Office cannot produce the "private" and "withheld" records you have requested.

While you are correct that some private or withheld voter information may be available to "government officials" in certain circumstances, statute limits those circumstances to when the government official is "acting in the government official's capacity as a government official". While you are an elected member of the State Legislature, there is nothing in your request letter that demonstrates that you are acting in the capacity of a government official or on behalf of a government entity or otherwise as a "qualified person" under 20A-2-104(4)(a), and (d)(i). Nor does it appear that any other statutory exception applies to allow the Office to deliver private records to you. Therefore, the Office hereby declines your request to the extent you seek voter information that is classified as private or withheld.

Even though the Office cannot provide all the records you seek, those records that are in the custody of the Office and classified as public can be provided in the format they are maintained by this Office. The Office estimates such records could be delivered to you on or before December 1, 2021. The estimated fee for us to compile these records would be \$1,380.00. A schedule of the Lieutenant Governor's Office record production fees is attached with this document.

Please communicate with this Office as to your continuing interest in the public records that the Office could provide as described. If you are not interested in these public records, please inform us of that decision. As the requestor for government records you have the right to appeal the denial of that request within 30 days. Appeals should be directed to the Chief Administrative Officer of the governmental entity, who in this case would be Lieutenant Governor Henderson, at 350 North State Street Suite 220 Salt Lake City, UT 84114.

Dear Representative Christiansen:

My office has received your letter dated September 14, 2021 requesting voter information and election records. Inasmuch as you have requested government records from a governmental entity, I interpret your letter to be a request under the Utah GRAMA statute.

Under GRAMA a governmental entity may postpone approval or denial under extraordinary circumstances, which my office deems applicable in this instance. The request you have sent seeks a voluminous quantity of records and would require my office to review a large number of records simply to locate the records requested. Furthermore, segregating the information that may be public and subject to production from that information that is classified private under GRAMA will also take considerable time. While I recognize your note that "time is of the essence," it is simply not possible to expedite your request or respond within the five days.

For these and other reasons listed as "extraordinary circumstances" under §63G-2-202(6), my office will require additional time to review, process and respond to your request. I anticipate that a formal response to your request can be communicated to you on or before Friday, October 1, 2021. Thank you for your understanding.

I need your advice: Do you think it's a good idea for the clerks and your office to do a combined presentation discussing the following talking points?

- Utah's elections are secure, accurate, fair, and audited. In fact, Utah elections are a standard to the nation.
- We could share the "Securing Utah's Elections" document with the committee and highlight some examples of election risks and what safeguards are in place to address them.
  - We are always looking for ways to make elections more secure, accurate and fair. We've completed a detailed review of the risks and safeguards of our elections, and have identified a few areas where we can strengthen even further the integrity of the process.

The LG and clerks are working together on the best ways to implement these improvements, whether it be via legislation, administrative rule, standards of practice, and training. This is a work in progress, but we will have related legislation for the 2022

session.

The Judiciary Interim Committee isn't the ideal entity to bring this forward, but they've been assigned this study topic, so they have to address it. I'm encouraged that Rep. Lisonbee reached out to us with this option, and that she's deferring to the election officials for how best to address this topic in her committee. Rep. Hawkins is on this committee, as well.

What suggestions to you have on how best to proceed? Is this the approach / forum that we want to take?


Representative Christiansen has provided during his presentation a number of inaccurate conclusions based upon misleading, incomplete or inaccurate data.

1 – In his first analysis of the voter trends, he uses total votes for candidates over the past 5 presidential elections, he demonstrated a trend line that would lead one to conclude where the "norm" should be.



These are accurate numbers, however they are presented in a purposely misleading manner with the intent to convince the viewer that Joe Biden's votes were so much higher than the norm that clearly there is a problem.


Here is an example of how the same data source can be used to tell a completely different story. Below is a trend analysis using the total votes for each candidate over the same period of time but converted to a percentage of the total votes cast in the race.



You can now see how the story changes, first you will notice that the trend indicates that the GOP candidates are moving in a downward slope while the democratic candidates are moving in an upward slope. In addition and most important you will see in 2020 that each of the major party candidates performed slightly above the trend (3-5 percentage points). No longer do we feel the shock and awe of a democratic candidate performing significantly above the "norm". I am not saying one analysis is better than the other, I am simply demonstrating that the data presented by Representative Christiansen was


specifically selected and presented in a way with the intent to create the impression that the results were so significantly out of the norm as to suggest that fraudulent activities are the only answer.

2 – In the second analysis that demonstrates the theory of an algorithm that is controlling voter registration and participation in our elections. The Representative provided an explanation of a complex algorithm theory reported by Doug Frank. It is described as an equation a Sixth order polynomial. He spends significant time helping the average person understand how complex this equation is and then proceeds to demonstrate how this equation can predict in "almost perfect accuracy" the number of votes cast by each age group.




It is interesting that creating this graphical representation requires such a complex mathematical equation, when it can more simply be created using the law of averages. (the commonsense observation that probability influences everyday life so that over the long term the possible outcomes of a repeated event occur with specific frequencies – Merriam Webster)

In the example below we took a complete data set of current (10-18-21) Davis County Voters grouped and totaled by age. We took the turnout from the 2020 general Election (90.1%) and multiplied each age group to estimate how many of each age group would have voted in that election. This becomes our "predicted ballots". We then included the actual total of ballots cast for each age group. You will see that our graph closely resemble the graph above, slight differences are attributed using a different data set time frame and our data set includes all voter files (private and public).



Our conclusion is that the complex mathematical equation the the sixth order polynomial is nothing more that smoke and mirrors put forward to lend legitimacy to this discovery. A discovery of nothing more than the fact that if you have an average turnout percentage determined for an election, it is reasonable to believe that that average turnout percentage will exist across all age demographics with only a slight deviation.

3 – Time Series Analysis – during this analysis conducted by Draza Smith data was used from the New York Times election data website. He shared that there were patterns discovered during this analysis. One is listed below. Representative Christinansen explained that Donald Trump received 57.75% of the votes over nine reporting periods he stated "which makes no sense".



The problem with this demonstration is that by his own admission the data was modified and "a few rows of data were <u>hidden</u> to highlight the pattern". In other words data was not shared that would not benefit the idea that something was wrong. This is the same as withholding evidence in a court of law that change the verdict of the jury. It is dishonest and irresponsible.

This analysis doesn't tell the full story. Looking at the full unaltered data set will help us fully understand what is happening here. First the date and time shown in the data reference London Zulu time, which is 7 hours earlier that Utah. So the time frame listed in Representative Christiansen's presentation would be 10:55 pm to 11:28 pm on November 3, 2020 (Election Night) in Utah. This is important to note, because most reporting of election results had already been completed by this time on Election Night. So let's first look at the time frames before 9:55 pm on election night starting at 8:06 pm.

As you can see the share of the votes between Trump and Biden continue to change as the night of reporting went on. This time frame which would include the majority of election result reporting, was omitted from Representative Christiansen's presentation. It represents 16 reporting periods. I ask why was it not included? My only assumption is that it was purposefully excluded because it didn't match his narrative that something nefarious was happening.

In addition it should be noted that the total votes reported during the reporting periods highlighted by Representative Christiansen were not shared. When we look at these totals they also help answer why there was not any significant changes to the share of votes for each candidate.

From 10:55 pm to 11:28 pm there was an increase of 13,743 votes reported a 1.3% increase of the total votes reported at that time. Whereas during the period of time that was omitted from Representative Christiansen's report there were a difference of 641,422 votes from the initial reporting period or 64%.

4 – Excess Ballot Analysis by Cindy Butler. During this analysis an inaccurate conclusion is presented relying on incomplete data and inaccurate assumptions. Representative Christiansen shared the image below. This analysis demonstrates and suggests that the number of ballots cast exceeds the realistic number of registered voters.

It was noted that the data set was limited because it did not include all voter files due to private voter and withheld voter status. It was stated that the Cindy knew how many voter registrations were missing because she took the total number of eligible rows and subtracted the total registered voters from the election results report. For Davis County 192,849 minus 123,605 equal the missing voters 69,244. This is a flawed assumption. This analysis failed to highlight two additional factors. First Cindy is comparing a data set from July 29, 2021 to a total number of active voters from November 2020. Eight months have passed between these two comparisons. People have moved into and out of the county. In addition the eligible rows from the July 2021 data set includes active and inactive voters, the Registered Voters listed on the Election Results only includes Active Voters. In comparison to data from 10-19-21 this is a difference of 83,304. So the conclusion that for Davis County, the full 100 % of the "missing" voters would have needed to vote is inaccurate. In fact only approximately 83% of the "missing" voters would have needed to vote.

This analyses demonstrates a gross negligence in using incomplete, and incompatible data sets in formulating a conclusion that we have more voters voting than registered to vote. Representative Christiansen was informed of this problem on October 15<sup>th</sup> and yet continues to share this information and offers legitimacy to its conclusions.

5 – Phantom Voter Analyses. Representative Christiansen inaccurately has stated that as a government official he has "the legal right to receive the complete voter data set from the Lt. Governor's Office" he stated that he requested this from the Lt. Governor's Office and that his request was denied, that there was "no good reason" for the denial.

State law allows for the release of private, controlled, or protected records under specific circumstances 63G-2-206(1)(e)(i).

These records may be released to a member of the Legislature if it is in relation to the Legislature's duties including the preparation or review of a legislative proposal or legislation; appropriations; or an investigation or review conducted by the Legislature or a legislative committee.

Representative Christiansen stated that "the purpose of wanting that data was to conduct a phantom voter analysis". This is clearly outside of the legislatively established requirements to obtain this data.

Because his request was denied he shared his belief that this type of behavior only serves to exacerbate citizens' distrust of government.

Our government officials are required expected to follow the law, the law does not provide for the release of private records unless you meet the requirements set forth in the law, regardless of the merits of the cause. Furthermore to suggest that by complying with the current law in some way "exacerbates citizens' distrust of government" is irresponsible.



The Office of the Lieutenant Governor has received your letter of September 14, 2021 and hereby replies to your request.

You have a ked for record that are cla ified a "private" under Utah' GRAMA tatute of U C A 63G 2 302(1)(i) (m) or withheld under U.C.A. 20A-2-104. These include records such as a voter's driver license or identification card number, social security number, email address, date of birth, or phone number. In addition, voter registration records from individuals who have declared their information private or opted to have their information withheld as private are "private" under GRAMA E cept in certain ituation, a governmental entity may not di clo e record that are private Accordingly. the Office cannot produce the "private" and "withheld" records you have requested.

While you are correct that some private or withheld voter information may be available to "government officials" in certain circum tance, tatute limit tho e circum tance to when the government official i "acting in the government official" capacity as a government official". While you are an elected member of the State Legislature, there is nothing in your request letter that demonstrates that you are acting in the capacity of a government official or on behalf of a government entity or otherwise as a "qualified person" under 20A-2-104(4)(a), and (d)(i). Nor does it appear that any other statutory e ception applie to allow the Office to deliver private record to you Therefore, the Office hereby decline your reque t to the extent you seek voter information that is classified as private or withheld.

Even though the Office cannot provide all the records you seek, those records that are in the custody of the Office and cla ified a public can be provided in the format they are maintained by thi Office The Office e timate uch record could be delivered to you on or before December 1, 2021. The estimated fee for us to compile these records would be \$1,380.00. A schedule of the Lieutenant Governor's Office record production fees is attached with this document.

Plea e communicate with thi Office a to your continuing intere t in the public record that the Office could provide a described. If you are not interested in these public records, please inform us of that decision. As the requestor for government records you have the right to appeal the denial of that request within 30 days. Appeals should be directed to the Chief Administrative Officer of the governmental entity, who in this case would be Lieutenant Governor Henderson, at 350 North State Street Suite 220 Salt Lake City, UT 84114



Ensuring election integrity is one of my key legislative priorities.



#### Lt. Governor Henderson,

Thank you for this response I look forward to the full response (and presumably the requested voter data to which I am entitled) no later than Friday, October 1, 2021.

On a related matter, may I bring to your attention a situation that has occurred and been verified in Colorado that poses a potential threat to the security of Utah 2020 election data. We're all aware that federal law requires that all data associated with a particular election must be retained for 22 months. Unfortunately, when the vendor of one of the election management systems performed a "trusted build" procedure (system update) in Mesa County, Colorado, significant information on that system from the November 2020 election was purged.

The link below is to a document provided by the Mesa County Clerk in Colorado that demonstrates the "substantial amount of data destruction" that occurred in Colorado and that could also occur in Utah (if it hasn't already) as a result of these vendor-initiated procedures. Note the sections on the table of contents under the heading "findings" that describe the extremely troubling nature of the data destruction. Fortunately, the Mesa County Clerk had captured a full forensic image of her election-related equipment before the system update that then allowed her to compare the data on her updated system to the data before the update. This comparison and the verification of the data destruction is what ultimately resulted in the linked report. These are serious risks.

Given these risks, I strongly encourage you to request that all county clerks in Utah capture and retain a forensic image of their election-related equipment and electronic data (election management system, scanners, etc.) to preserve a record of the election information pursuant to federal law. It would be extremely unfortunate if a similar situation occurred in Utah as occurred in Colorado and our election officials hadn't taken the appropriate protective steps to secure a copy of the data in order to avoid finding themselves in non-compliance with federal law.

Will you please notify me within a week as to whether the above-requested protective measures will be taken in each of our counties in Utah?
