Re: GRAMA Request for Dates and Times that Ballots were Adjudicated and Duplicated

Dear [REDACTED]:

The Salt Lake County Clerk's Office received your emailed GRAMA request on July 4, 2021. Your request states:

Please provide all documents, emails, correspondence that show the dates and times that ballots were duplicated or adjudicated, who duplicated or adjudicated ballots at those times, and who was involved in being a poll watcher when ballots were being duplicated or adjudicated.

You provided the date range of October 1, 2020 to March 30, 2021.

On a previous GRAMA request, the Salt Lake County Clerk's Office sent you all duplication logs for 2020. This was provided via email on Thursday, July 1, 2021. Please refer to those records for your requests regarding ballot duplication records.

Attached are poll watcher registration forms and logs that identify poll watchers and observers for the date range that you provided. Poll watchers do not identify what tasks they are observing. We have redacted as necessary to remove personal identifiers, as required by Salt Lake County Municipal Ordinance 2.81, which includes home telephone numbers, personal cellular telephone numbers, signatures, and personal email addresses.

It will take us two additional weeks to go through all of the records/ correspondence for the other records you seek. GRAMA allows governmental entities to charge reasonable fees to cover the governmental entity's actual cost of providing a record. The fee includes staff time for searching, retrieval, and reasonable fees associated with formatting or interfacing the information. See UCA 63G-2-203. It would take the Salt Lake County IT Dept and the County Clerk's Office, at a minimum, three hours to go through the volume of requested records and prepare them to provide to you. **The cost would be \$209.33. We would require upfront payment prior to beginning the work.**

You may appeal Salt Lake County Clerk's denial of the records pursuant to GRAMA §63G-2-204 & Salt Lake County Ordinance §2.82.040C by filing a written appeal within 30 calendar days of receipt of this letter to the following address:

- (d) An election official may not prohibit a watcher from performing a function described in Subsection (4) because the watcher did not provide the notice described in Subsection (2)(c).
