Hi Marilyn,

I had several question regarding your request for \$4,020 for postcards to unaffiliated voters for the Primary Election:

- Did the county plan or budget for letters to unaffiliated voters prior to the coronavirus epidemic, or would the county otherwise not have sent out the letters if it wasn't for the mandate in HB3006?

If you did plan or budget to send these letters beforehand:

- Did you have to make modifications to the postcard to include coronavirus information (e.g., the original size was 4" x 6", but the additional information required 5" x 7")?
- Did you have to reprint the postcards to include coronavirus information?
- Did you incur any other costs on the postcards due to the coronavirus?
