




## Reason for Hope



### Colorado

- **Grassroots individuals have been elected into 2 of the 3 State GOP executive positions**
- **Grassroots have successfully utilized the Precinct Project and filled seats with motivated members who are not part of the self-interested Establishment.**
- **Higher percentage of Central Committee members are more aware of the dangers The People are facing with regards to election irregularities**

# Reason for Hope: Lawsuit Success

## Colorado

Lawsuit to CLOSE the unconstitutional Open-Primary has been filed again - this time with Colorado GOP chairman's signature.

- Previously dismissed because former COGOP chair and legal team (Dominion-affiliated) lied about their efforts to move it forward - as was directed by Central Committee member vote in Sep 2021
- Wouldn't sign while "waiting" for reply from FEC - while in fact they sent it to the wrong agency "by mistake" and did not follow up until only a few days before transition.

New COGOP team brings transparency and integrity back to the party

- Old party was wasteful. FEC reports were inaccurate and have been ~\$93k off-balance for approx. 10 years. There was fraud and other misdeeds - all while barking conservative talking points at the fundraising dinners
- Grassroots and small donors have their party back under Chairman Dave Williams and Secretary Anna Ferguson

# Reason for Hope: Lawsuit Success



## Colorado

Citizens and candidates continue to fight:

- 2022 post-primary lawsuits over illegal conduct of the recount under Colorado Revised Statute - appealed to Colorado Supreme Court but were ultimately denied consideration
- Rep Lauren Boebert's close CD3 race in Nov 2022 triggered an automatic recount. The conduct of the recount was challenged by private citizen, but challenge was dismissed

Grassroots activists continue to fight:

- Encouraging County Commissioners to defund Dominion/other voting machine contracts.
- Fighting to "OPT OUT" of unconstitutional Open Primaries - conduct vote as a party without hostile, partisan state executive branch intrusion

Some counties are willing to defund the Dominion Contract if a legal defense fund is available

- Soros-funded SoS has been hostile toward counties
- Will sue to coerce or bankrupt

Some counties are working to hand tally the ballots alongside of the tabulators.
