Subject: FYI-Short Summary of Approval Voting

Here's a good summary of Approval Voting, from the impartial NCSL.

Approval Voting

Approval voting is a system which allows voters to cast votes for as many candidates as they like in a given race rather than just one single candidate. This allows voters to answer the question, "Do you approve of this person for the job?" The votes are then tallied normally and the candidate that receives the most votes wins the election, similar to plurality voting.

Approval voting will result in vote percentages that add up to more than 100 percent. Supporters argue that the system better represents the degree of support for third parties, makes the system more resistant to tactical voting or having third parties take away votes from major party candidates, and may lead to the election of more moderate candidates. Opponents, however, contend that approval voting may be vulnerable to strategic voting, is hardly used in competitive elections for this reason and could result in candidates that receive the first choice support of more than 50 percent of voters losing to a candidate without a single first choice supporter.

Currently, approval voting is not widely used, but is used by the United Nations in a multi-round election to select the secretary-general, and by some political parties and other private associations. In 2018, voters in Fargo, N.D. approved a ballot initiative implementing approval voting for their municipal elections; the city held the nation's first-ever approval voting election on June 9, 2020.

Subject: FYI-Weekly Elections News Alert- a pilot project re: elections security

Utah is one of about 6 states participating in a nationwide pilot project regarding elections cybersecurity. The team, which is being led by the Department of Homeland Security (DHS) and the Multi-State Information Sharing & Analysis Center (MS-ISAC), sends out weekly emails that are elections related (see below). They try to keep them high level and non-technical so folks like me can understand them, but they also provide links to more technical resources so your I.T. folks can get the detail that they need.

This pilot is the beginning of a nationwide cooperative effort between the DHS, EAC, iGO, Election Center, NASS (National Assoc. of Secretaries of State), NASED (National Association of State Election Directors), NIST, and other entities to establish a national information sharing framework that helps bring high-end cybersecurity knowledge & resources to every election official at the state and local levels. The governing group for this work is made up of 28 federal, state, and local election officials (the 9 local officials and state election directors are working to make sure the Feds are not overstepping or encroaching on what is truly a state & local function).

Also, in this email is notice of federal legislation that proposes to strengthen elections cybersecurity, including federal funding (similar to HAVA). It was just introduced last week and is certainly not perfect, but at least it's the beginning of a national discussion on the importance of security in elections. It should be helpful as we work to obtain funding from the state legislature.

"Secure Elections Act" 115th Congress, 1st Session (2017)

TLP: WHITE Senators James Lankford (R-Okla.), Amy Klobuchar (D-Minn.), Kamala Harris (D-Calif.), Susan Collins (R-Maine) and Lindsay Graham (R-S.C.) sponsored a Senate bill to increase federal support to state elections officials. The bill, nicknamed the Secure Elections Act, incorporates a number of provisions and designations, including:

- directs the U.S. Department of Homeland Security and other federal agencies to share cybersecurity threat information with all relevant parties, in a timely manner, unless there is good cause to withhold the information. This includes sharing threat indicators, defensive measures, identifying and sharing available resources, and declassifying material when possible, as well as taking steps to ensure the personal information of voters is appropriately protected;
- directs varying agencies and officials to provide formal notifications of cybersecurity incidents. This includes directives for election agencies to notify state election officials and election service providers, for election agencies to notify the Secretary of Homeland Security, and for federal entities to notify the appropriate Congressional committees;
- directs the Secretary of Homeland Security to establish a process, within 30 days of the Bill passing, to expedite security clearances for state election officials, designated technical personnel, and other pertinent parties;
- directs the Secretary of Homeland Security to provide a publicly-available catalog of federal resources available to election agencies;
- directs the Secretary of Homeland Security and Chairman of the Election Assistance Commission (EAC) to assess the MS-ISAC and other mechanisms for inter-state cybersecurity information sharing, and issue a report including comments from state election agencies;
- directs the Secretary of Homeland Security to establish an advisory panel of experts on elections cybersecurity to provide recommendations and guidelines (e.g. on the inclusion of paper ballots and audits), identify top risks, and provide detailed explanations and strategies;
- directs that grant programs be created for state election programs to modernize state election hardware, software, and services, remediate cyber issues discovered during assessments, and conduct other security related activity. The Bill also directs the creation of a "Hack the Elections" program, which will provide voluntary assessments for election agencies; and
- directs the Secretary of Homeland Security and the Director of National Intelligence to provide a yearly report to Congress on the foreign threats, physical and cyber, to elections in the U.S.

The Bill also explicitly authorizes the sharing of information with non-Federal entities, and names the MS-ISAC for this purpose.

"Russian Hackers Hunted Journalists in Years-long Campaign" AP (12/22/17)

TLP: WHITE According to the Associated Press, the Russian nation-state cyber threat group, Fancy Bear (a.k.a. Iron Twilight), known for targeting the Democratic National Committee in 2015-2016, is also responsible for targeting journalists around the world. A Russian television anchor was reported to have been targeted in 2015, with the Fancy Bear actors having access to personal emails and Facebook messages for approximately nine months before the messages were leaked. Targeted journalists reported co-workers being targeted in an event to gain access to their accounts and unusual events occurring after their accounts were targeted, including noticing an increase in Russian-speakers at events that were on their calendars. Since March 2015 the Fancy Bear actors targeted approximately 200 journalists, publishers, and bloggers, around the world. Only diplomatic personnel and U.S. Democrats were more targeted.

MS-ISAC Analyst Note: Nation-state actors are known to be highly persistent in their campaigns, targeting both professional and personal accounts, co-workers and friends, as well as gaining access and then monitoring

CORRECTIONS TO GEPHARDT'S "TAXPAYERS COULD SAVE THOUSANDS"

KUTV News recently aired a Get Gephardt segment highlighting tax relief programs for Utahns. We appreciate his bringing attention to our tax relief programs, and we would like to correct a few errors and omissions in the segment.

1. The deadline to apply for tax relief in Weber County is **December 31st**, not the September 4th deadline stated in the Gephardt piece. So relax, you've got time.
2. Gephardt said there were tax relief programs for veterans, but he did not mention that to qualify, you must have a service-related disability rating from the VA of at least 10%.
3. The limit on an applicant's assets varies, depending on the program and the age – some of the programs do not have asset limits. Give us a call and we'll walk you through the details.

As stated in the news piece, we offer many Tax Relief programs:

- Blind – If an eye doctor has certified that you are legally blind in both eyes

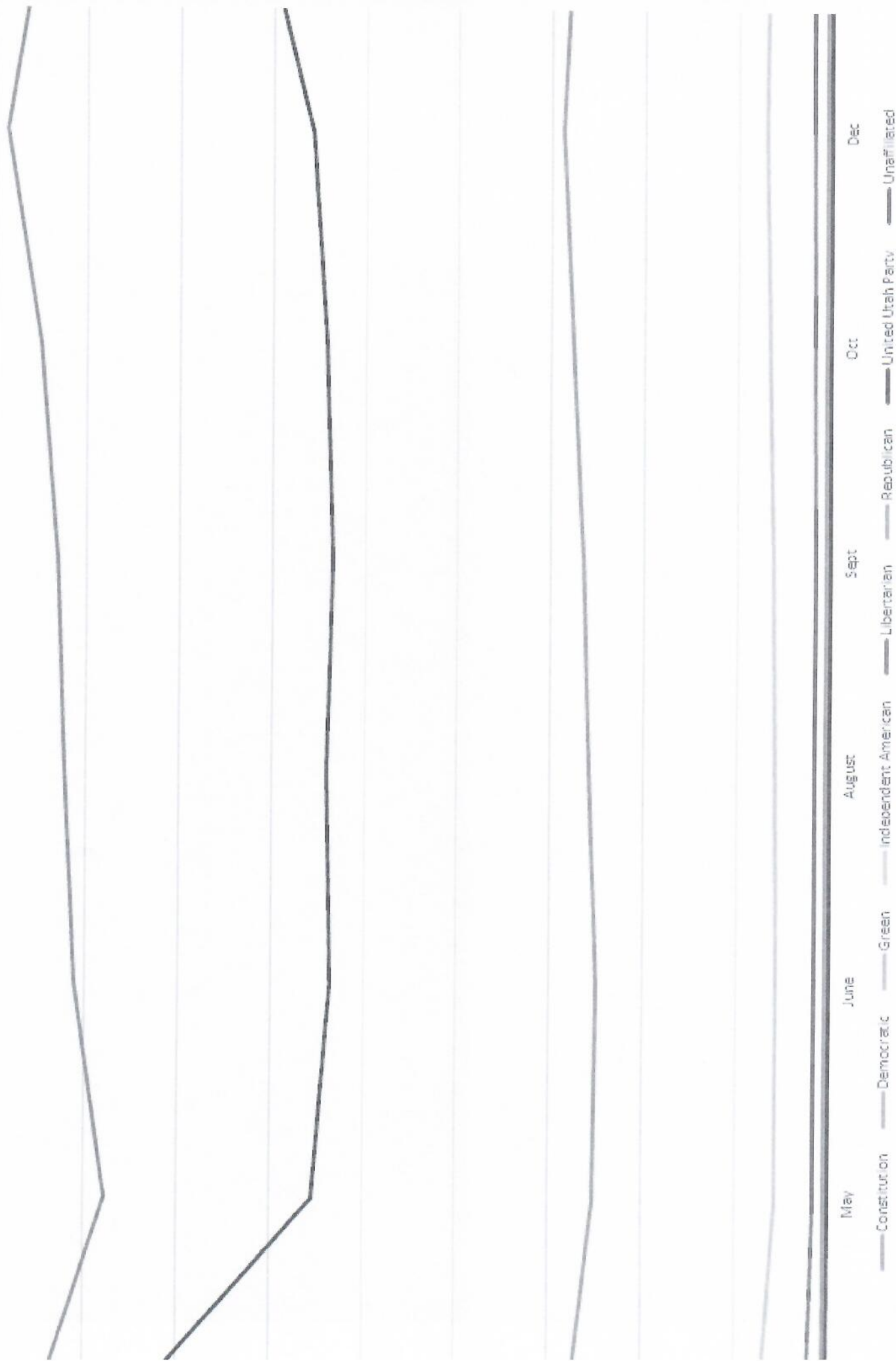

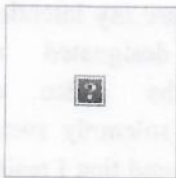

1) Because we do not preform or solemnize any marriages in Utah County as the County Clerk's Office (we only issue the licenses), the question I have is, will this bill make it so our Office will now have to provide a reasonable accommodation for same-sex marriages that were are not currently providing for traditional marriages? Or, as long as we are providing a list of individuals that are willing to preform/solemnize any type of marriage are we covered?

SB297 came out Thursday, passed through Committee on Friday, and will be discussed in the Senate early next week. It addresses anti-discrimination, allowing for some religious exemptions. It also impacts our offices.

This email summarizes how SB297 impacts Clerks, and suggests some possible amendments. PLEASE PROVIDE YOUR INPUT!

Here's how it impacts County Clerks:

- County Clerks will be required to provide couples with access to a marriage officiant.
- Clerks could not force an employee to solemnize a marriage, if doing so would go against that employee's sincere religious or deeply held beliefs.

designated by the Clerk. This allows couples to have Grandma/best friend/boss/etc. solemnize, which would likely make the ceremony more personal and meaningful than if a stranger were to solemnize.

3. If the bill's sponsor insists that an officiant be "on call," and that ceremonies be performed on site, we may wish to point out that many counties do not perform "walk-in" ceremonies, but rather **require appointments**. Weddings are often disruptive to the Clerk's office (and often other office) functions. The Post Office and some counties require appointments for passports (often because of staffing considerations). It seems reasonable to require appointments for weddings, or to designate certain days/times when ceremonies can be solemnized on site.

4. Another option would make the wedding ceremony optional, but that idea seems not to have much traction right now.

One of the sponsor's arguments is that "government has a monopoly on marriage.." This isn't completely accurate. Yes, government has a monopoly on the marriage licensing process, but definitely NOT on the marriage ceremony business. This bill, as currently written, forces Clerks into the marriage ceremony business.

It is important to keep our terminology consistent. I recommend that we refer to heterosexual marriages as "traditional marriages" and same-sex marriages as "same-sex marriages." This is widely accepted terminology.

FYI – this bill seems to be on a fast track, and is viewed as a companion bill to SB296, another anti-discrimination / religious rights bill. The Eagle Forum and Sutherland Institute fully support it. Equality Utah, Alliance for a Better Utah, and the ACLU want it amended more before moving forward, but seem hopeful that it can also become acceptable to them. What you cannot do, is to refuse to perform marriages or fail to have someone available to perform a legal marriage under reasonable circumstances.

The main issue of concern to us is whether Clerks should be forced into the marriage ceremony

business. State code allows Clerks to choose whether or not to solemnize marriages. This bill forces Clerks to either solemnize marriages or to designate someone to solemnize marriages. I doubt any Clerk wants to be forced to solemnize marriages, even if they choose to solemnize - this choice should remain with the Clerk. However, the bill appears to provide Clerks with the ability to provide access to an officiant without being forced to be an officiant, and that is through the "designee" language.

The bill's sponsor said he is willing to work with Clerks to address our concerns. The bill says that the Clerk must establish a "policy to ensure that the Clerk or the Clerk's designee is reasonably available to solemnize."

Here are some possible amendments that might satisfy all parties:

1. **The Clerk provides a contact list of "designated officiants" to applicants.** These officiants must agree to comply with state code governing marriages, and to be "reasonably available" to solemnize marriages. The couple can then contact their desired designated officiant, and schedule the ceremony directly with them.. The Clerk may choose to be on the list, or to put an employee on it, or both, or neither. I know Utah & Weber Counties (and probably a few others) already provide a list of judges who solemnize. This option may involve some extra work to keep the list current.
2. **The Clerk designates someone as an officiant for a day, with specific authority only to perform the wedding that is being requested.** Massachusetts currently does this. Note, the designated officiant is only designated, not deputized. The process of designating would likely be providing a preprinted designation form with the officiant's name. It does not require personal action by the Clerk. Couples could bring their own officiant, who can be designated by the Clerk. This allows couples to have Grandma/best friend/boss/etc. solemnize, which would likely make the ceremony more personal and meaningful than if a stranger were to solemnize.

I apologize to those Clerks who have not yet received any emails on this bill. It appears that the countyclerks Listserve that I used earlier Friday isn't current.
