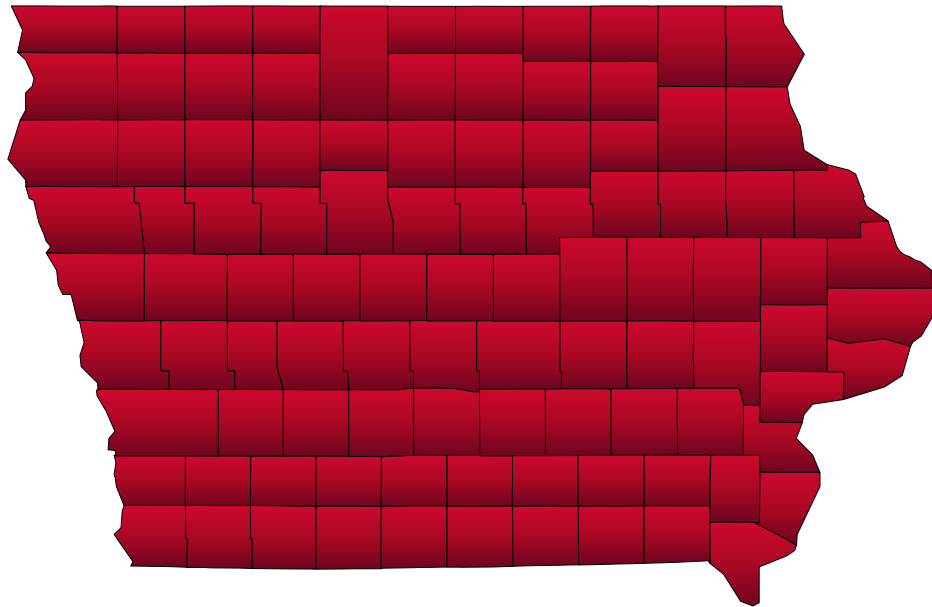

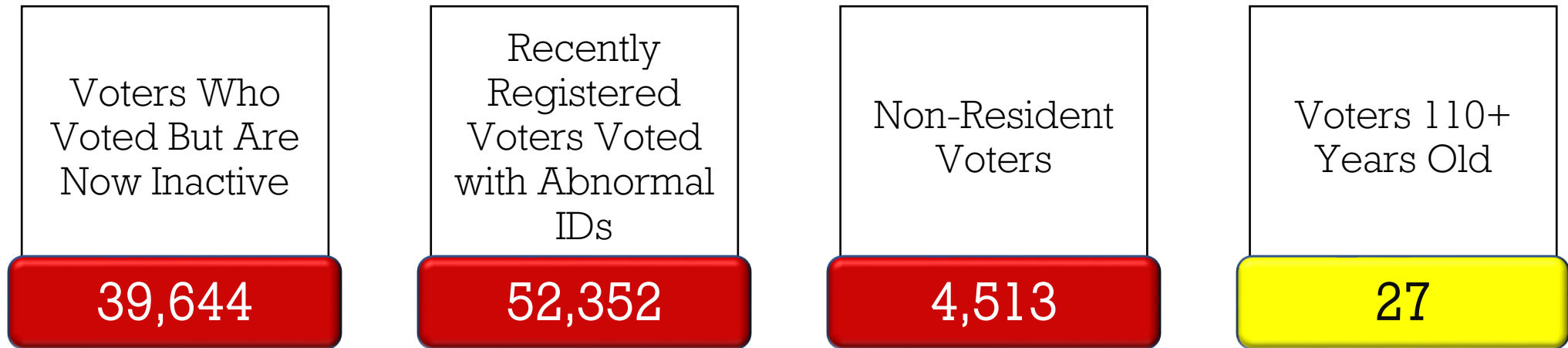

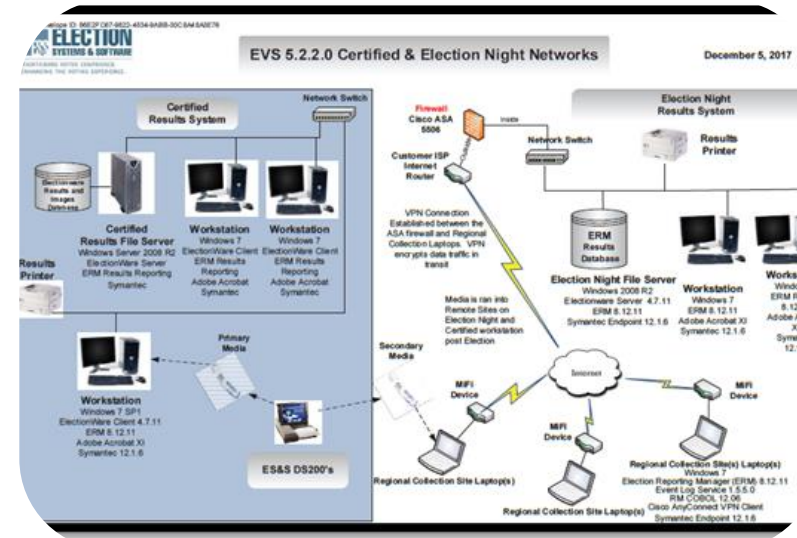
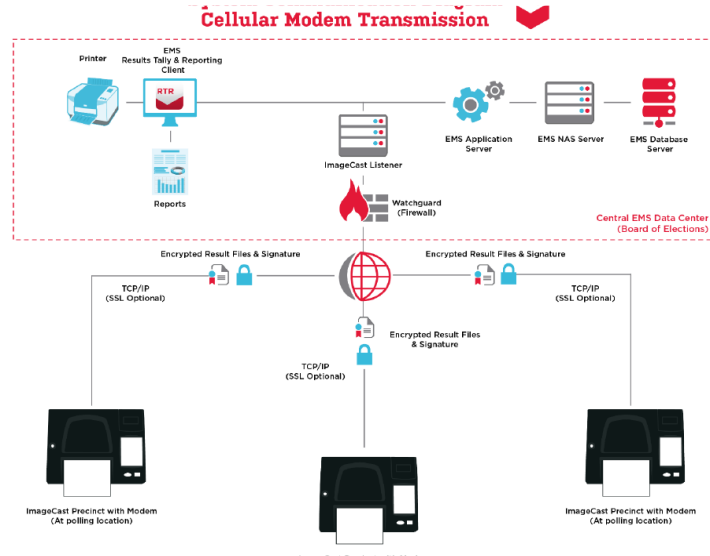

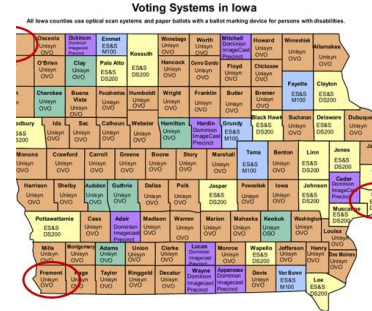

Roadblocks

Machine Vulnerabilities

- Electronics need to be better controlled and secured.
 - Poll books
 - Tabulators
- Address the cyber side of election integrity.

Voter Verification

- Courts struck down the Iowa law requiring voter signature verification on absentee ballots.
- Lack of ability to verify the early voting ballots as legitimate.

Oversight Barriers

- Insufficient quantity of poll watchers available to be at every precinct.
- Validation of tabulator process is publicized and easily programmed to pass.
- Risk-limiting audits using random precinct per county to hand count
- There is no way to validate if CVRs or data against actual cast votes.

Voter Rolls

- Iowa uses Electronic Registration Information Center (ERIC) system.
- Onerous process to remove ineligible voters.
- Iowa UOCAVA voters, and especially non-military, addresses or locations cannot be verified.
- Counties cannot provide details on why the rolls do not match the numbers reported by the SOS.



Victories

SOS Improvements

- Date of the absentee ballot request is required on the form.
- County auditor may deny a request for a satellite voting station if select requirements not met.
- Simplified process for disabled voters to submit ballots and protect from ballot harvesting.

New Election Laws

- Election misconduct penalties.
- Mandates voter registration maintenance for SOS & county auditors.
- Tighten security on absentee ballot requests, early voting timelines and deadlines for receipt of absentee ballots.
- One drop box per county with video and additional security precautions.
- Path forward to restore voting rights to felons.
- Private money prohibited.

Data Retention Injunction

- Injunction to retain 2020 ballots beyond 22 months submitted (EQCE087911) – Plaintiffs Tony Camero & Santiago Sanchez-Warner of Polk County

Republican State Platform

- Included in Republican Party of Iowa platform: *“Supporting the efforts of the various states (including but not limited to Wisconsin, Michigan, Pennsylvania, Georgia, and Arizona) involved in ongoing legal challenges seeking ultimately to de-certify the 2020 Presidential Election vote due to the findings of massive irregularities and fraud.”*
