Executive Summary

1. **Three narratives:**
 - a. King County election officials secretly committed election fraud by adjudicating ballots after a post-election audit.
 - b. The Yakima City mayor lacks knowledge of signature gathering laws and tried to suppress voters.
 - c. Skagit County officials will be recalled for misconduct and oath of office violations.
2. Two of the narratives targeted the election process in Washington state, and two of the narratives also targeted individuals involved in Washington state elections.
3. We observed a resurgence in a previously flagged narrative titled "Washington State enables voter fraud by registering non-citizens to vote when they receive a driver's license." National-level discourse about the implementation of automatic voter registration procedures in Pennsylvania likely sparked this resurgence.
4. **No L1 threats¹ identified against Washington state's Secretary of State Office staff.**

Election Narratives

Narrative	Description	Impact
1. King County election officials secretly committed election fraud by adjudicating ballots after a post-election audit.	<p>Users online claimed that King County election officials adjudicated thousands of ballots after Election Day and a post-election audit, which undermined the integrity of the November 2022 election results. Users claimed that adjudicating ballots after an election audit, outside of business hours, and with no observers ensured that election officials could steal an election undetected. Users shared the narrative alongside a September 9 Washington-based election blog, a September 14 Substack article, a September 20 Substack article, and a September 28 YouTube video, which stated that Secretary Hobbs neglected his investigative duties.</p> <p>Over 420 users on <i>Telegram</i> shared videos and graphics from an “election integrity” channel that used King County as an example for election fraud via ballot adjudication. A prominent election influencer shared the graphic and a Substack article about King County elections to his audience of 105k subscribers, garnering 90 shares and 468 interactions.</p>	<p>This narrative could degrade confidence in Washington state and King County's ballot adjudication procedures and post-election audits among those who believe that election officials commit election fraud.</p> <p>The narrative may discourage individuals from participating in future Washington state elections.</p> <p>This narrative could generate threats to Secretary Hobbs and lead to calls for changes to election procedures and an investigation into the King County Elections Office.</p>

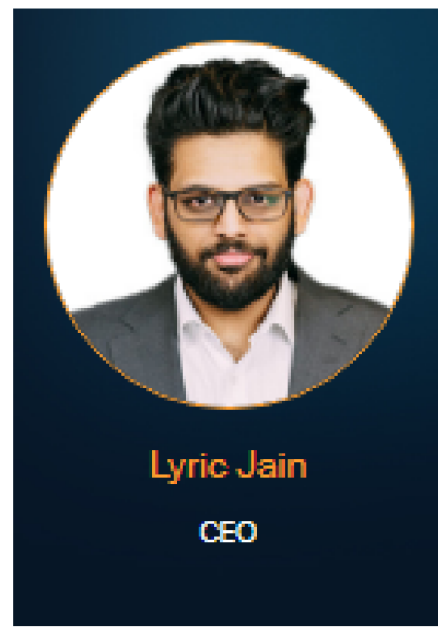

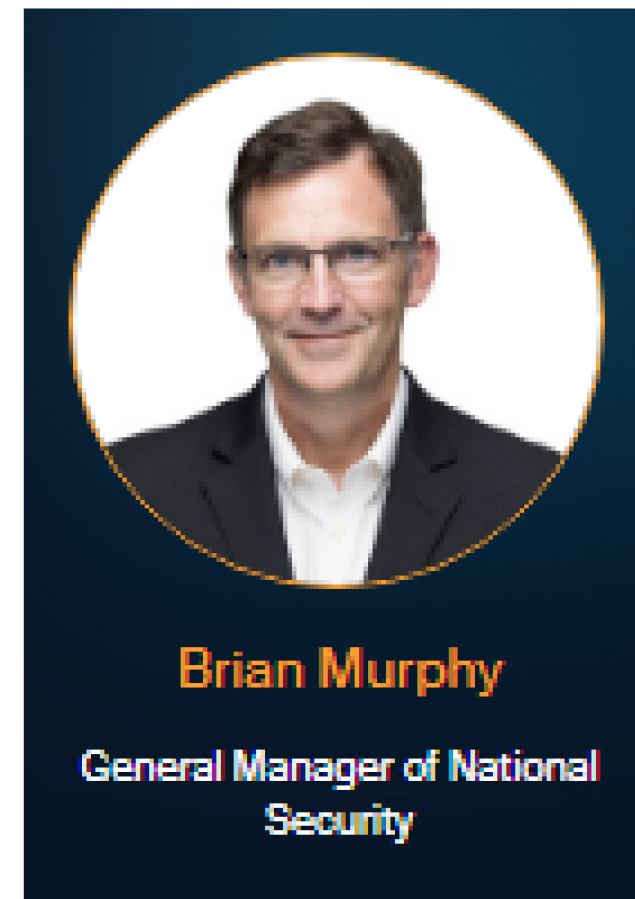

NOT PUT OUT FOR BID

The WA SOS didn't want to put it out for bid, so they first considered a sole source contract but ended up having South Puget Sound Community College put the bid out and hire Logically for a 15% fee in attempt to stay under the radar.

ON HAND: CO, OR, WA

It appears Ohio was one of the earlier states to contract with Logically, as they are used as a reference for the other states. Oregon did a short 6 month contract at first for \$40K. Washington ended up paying \$272K including the college's 15%.

Description of Services

Contractor shall review publicly available content across social and online media for MDM related to the 2022 midterm elections in Oregon.

Contractor shall provide the following overarching services through a combination of Contractor's professional services and threat intelligence platform Logically Intelligence (LI):

1. MDM Monitoring
2. MDM Reporting
3. Recommended Countermeasures
4. MDM Alerts

Scope of Work

Deliverable #1: MDM Monitoring

Contractor shall review social and online media for MDM while also training select Agency staff on how to use Logically Intelligence (LI) to perform MDM monitoring themselves:

1. Contractor shall perform MDM monitoring on behalf of Agency from Contract Kick-off until September 1, 2022:
 - a. LI is configured for Agency.
 - b. Agency staff receives training on how to use LI.
 - c. Agency staff can be properly trained on how to use LI.
2. During the aforementioned time period, Contractor shall perform 24/7 monitoring during special circumstances agreed upon between Contractor and Agency.
 - a. Agency will be able to conduct 24/7 monitoring once Agency is onboarded onto LI.

Deliverable #2: Weekly MDM Report

Contractor shall provide Agency with a weekly MDM report by 14:00 Pacific Time (PT) on Fridays with potential MDM narratives, MDM threats, and recommended countermeasures:

1. Contractor shall identify potential MDM narratives and threats across social and online media.
 - a. Contractor shall define “narratives” as at least more than one piece of content that shares a similar rhetorical objective that pose a potential risk to electoral integrity in Oregon.
 - b. Contractor shall define “threats” as individual pieces of content that pose a potential risk to electoral integrity in Oregon.
2. Contractor shall include analysis on the potential MDM narratives and threats, which could include but are not limited to:
 - a. Risk level posed by MDM narratives and threats to Oregon’s electoral integrity.
 - b. Trends related to MDM narratives and threats observed.
3. Contractor shall include recommended countermeasures that Agency can take to address the MDM narratives and threats, which could include but are not limited to:
 - a. Public messaging that includes factual information to mitigate the risk posed by a MDM narrative.
 - b. Agency reports the MDM threat to a social media platform for violating their community guidelines and/or policies.

Deliverable #3: MDM Alerts

Contractor shall provide Agency and relevant stakeholders with alerts related to MDM topics agreed upon between Logically and SoS:

1. Agency shall provide Contractor with a list of relevant stakeholders and shall work with Contractor to identify their preferred means of communication, which could include but are not limited to:
 - a. Email.
 - b. Text message.
 - c. Dashboard.
 - d. Regular reporting meetings/updates.
2. Contractor shall alert Agency of any identified potential threats to life and/or property.
 - a. Contractor shall define “threats to life and/or property” as information that *any reasonable person would interpret as a real and serious communication of an intent to inflict harm*. This content could describe, encourage, suggest, or condone a specific act of violence against Agency personnel, county elections personnel, or facilities.

2. King County did not perform proper logic and accuracy testing during the August 2023 election.	<p>Users online claimed that King County election officials did not properly conduct a logic and accuracy (L & A) test after replacing a tabulation server during the August 2023 election, which enabled election fraud. Users criticized the King County Elections Director for a lack of transparency and accused her of lying about performing an L & A test. Users shared a <u><i>Rumble</i></u> video which claimed that redacted information and perceived irregularities in tabulation server logs proved officials processed ballots using an uncertified tabulator. <u>Local political influencers</u> and news outlets also discussed the alleged August election irregularities in recent weeks.</p> <p>Users shared this narrative on <i>Facebook</i>, <i>Rumble</i>, <i>Telegram</i>, <i>Truth Social</i>, and <i>X</i>. Eight users on <i>X</i> shared the narrative, garnering a total of 118 likes and 33 shares, including one post which called on Secretary Hobbs and AG Ferguson to audit the election, which garnered 103 likes and 26 shares. Two <i>Telegram</i> users posted about this narrative, garnering a total of 43 likes and 56 shares.</p>	<p>This narrative could degrade confidence in the election process in King County among those who believe that the county election officials did not conduct a proper L & A test during the August 2023 election.</p> <p>The narrative may also motivate individuals to call for state officials to investigate whether King County elections staff conducted a proper L & A test during the August 2023 elections and redacted relevant information from tabulation server logs.</p> <p>The narrative could generate threats against King County election officials from users who believe that election officials committed election fraud during the August 2023 elections.</p>

Emerging Narrative: King County Election Officials Secretly Committed Election Fraud by Adjudicating Ballots After Post-Election Audit

Information current as of 3:00 pm EST, Monday, September 18, 2023

Description

Users online claimed that King County election officials undermined the integrity of the November 2022 election results by adjudicating thousands of ballots after Election Day and a post-election audit. Users questioned why system logs acquired through public records requests appeared to show election officials adjudicating thousands of ballots outside of business hours with no observers present. Users also claimed that waiting to adjudicate thousands of ballots until the election passed an audit ensured that election officials could steal an election undetected. Many users shared the narrative alongside a graphic from a Washington-based [election blog](#) or a [Substack article](#) from the chairman of a Washington political party's election integrity team.

Dissemination

Users shared this narrative on *Facebook, Rumble, Telegram, Truth Social*, and *X*, with *Telegram* and *X* containing the most engagement.

- **Telegram:** Over **420 users** shared videos and graphics from an ["election integrity" channel](#) that used King County as an example for election fraud through ballot adjudication. A prominent election influencer shared the [graphic](#) and a [Substack article](#) about King County elections to his audience of **105k subscribers**, garnering **90 shares** and **455 interactions**.
- **X:** A [former candidate for the Washington State House of Representatives](#) shared the narrative to their **10.5k followers**, garnering **50 likes** and **26 shares**. Three other users posted about the narrative, garnering an additional cumulative **nine likes** and **10 shares**.

Impact

This narrative could:

1. Degrade confidence in Washington state and King County's ballot adjudication procedures and post-election audits among those who believe that election officials commit election fraud.
2. Discourage individuals from participating in future Washington state elections.
3. Generate calls for changes to election procedures and an investigation into the King County Elections Office.

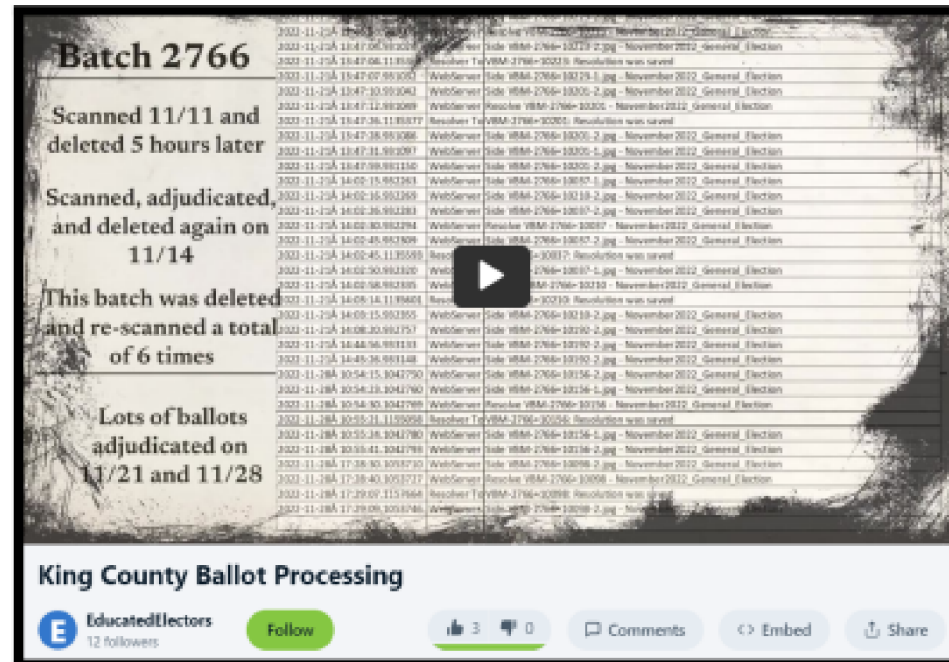

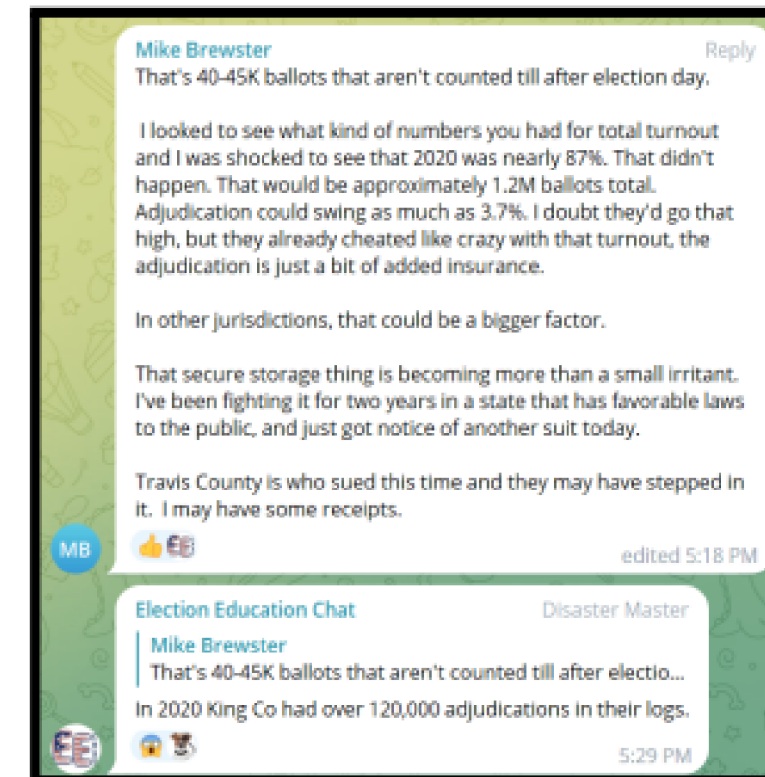

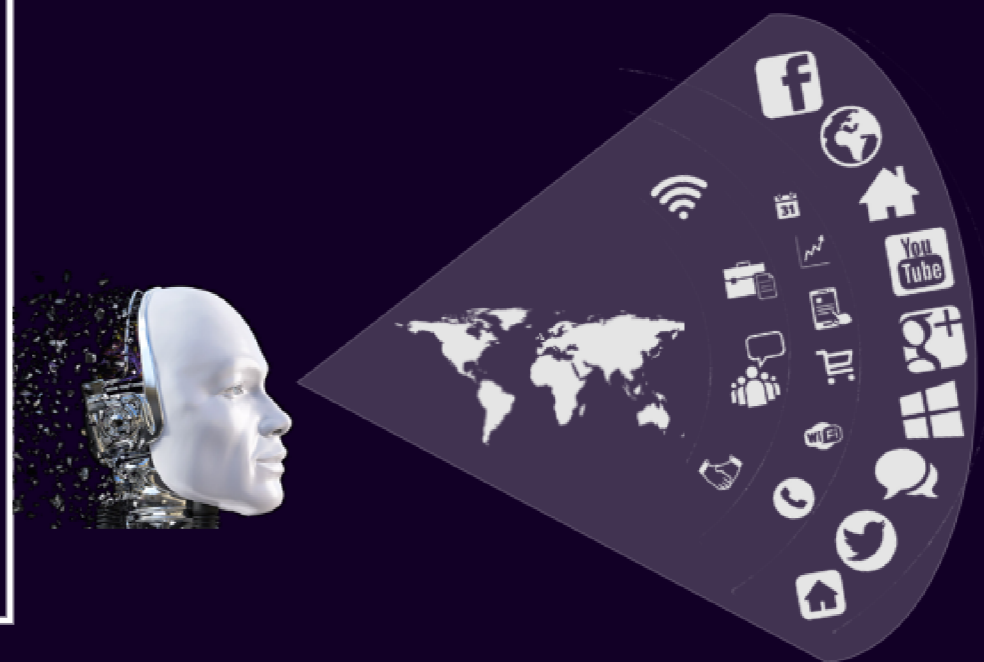
