



# Explain This




Voters report signing in on pollbooks and voting but official election results show them NOT voting



In targeted Harris County survey of 3300 homes w/6+ reg voters voting in last 2-3 elections, 49% were invalid!



County voter records differ from Texas Secretary of State records by 1% to 3%.
Which do we trust?



In Tarrant County, Biden "won" by 0.2% (1.8k votes); but all down ballot races won by GOP by 5% to 10%.





## Roadblocks

#### Law

- New ruling prevents State AG from pursuing election code violations without referral from local DAs (who refuse)
- Texas not following election law and SOS approving alternative procedures (eg., sequentially numbered ballots)
  - AG opinion requested but not yet provided

#### Obstruction

- Texas SOS advising Election
   Administrators not to honor FOIA requests for CVRs RULING
   OVERTURNED by AG 8/17/2022!
- SOS and some counties slow or non-responsive to FOIA requests for publicly available records
- Excessive fees from SOS office for statewide records (~\$1600 for list of all 17+M registered voters)
- Difficulty getting Counties and SOS to address challenged voters in a timely fashion

### GOP/Election Officials

- Belief election machines safe/convenient, do not support paper ballots/hand counting without more evidence
- Hand count resolution failed at GOP State Convention
- No authorization for Equipment Forensic Imaging
- Election officials/GOP leaders question Canvass results, assume voter memory issues, confusion or lying.





# Victories – Priorities, Law & Legislation

#### GOP Convention – Jun '22

- Resolution challenging legitimacy of the 2020 election and Joe Biden's presidency
- Election Integrity top Legislative Priority
- GOP Platform includes forensic images of equipment & removal of Texas from ERIC

#### Case Law Precedence

- Brownsville School Board
   Case election overturned
   due to number of illegal
   voters exceeded margin of
   victory
  - New election called
  - Sets case law precedence

### Election Integrity Legislation

- Requirement for election reconciliation
  - Resulted in uncovering 10k uncounted Harris County 2022 Primary ballots, Election Administrator fired
- Tightened residency requirement, including no PO Box registrations





## Victories – Grassroots Action

### Canvassing (Post Election Voter Interviews)

- Canvassed 7 Texas
   Counties, over 13000
   doors knocked
- 12% of registrations invalid (not living at registration address)
- 2.7% of votes recorded came from invalid registrations

### **Voter Roll Quality**

- Faced w/ losing \$4M/yr in state funding for failing to maintain voter rolls, Harris County placed 141k voters in suspense
- An additional 82,600 registrations reviewed and challenged state wide

#### Monitoring

- Review new registrations/votes against suspect registrations; report immediately, challenge races as necessary
- >3k voters from ineligible addresses voted in Travis Cty Mar '22 Primary, but challenge Denied

#### Training/Organizing

- Concerted effort by state GOP, local groups to train and staff Poll Workers, Judges and Poll Watchers
- Growing community involvement at County Commissioner's Court, requesting accountability for uncertified machines.
