

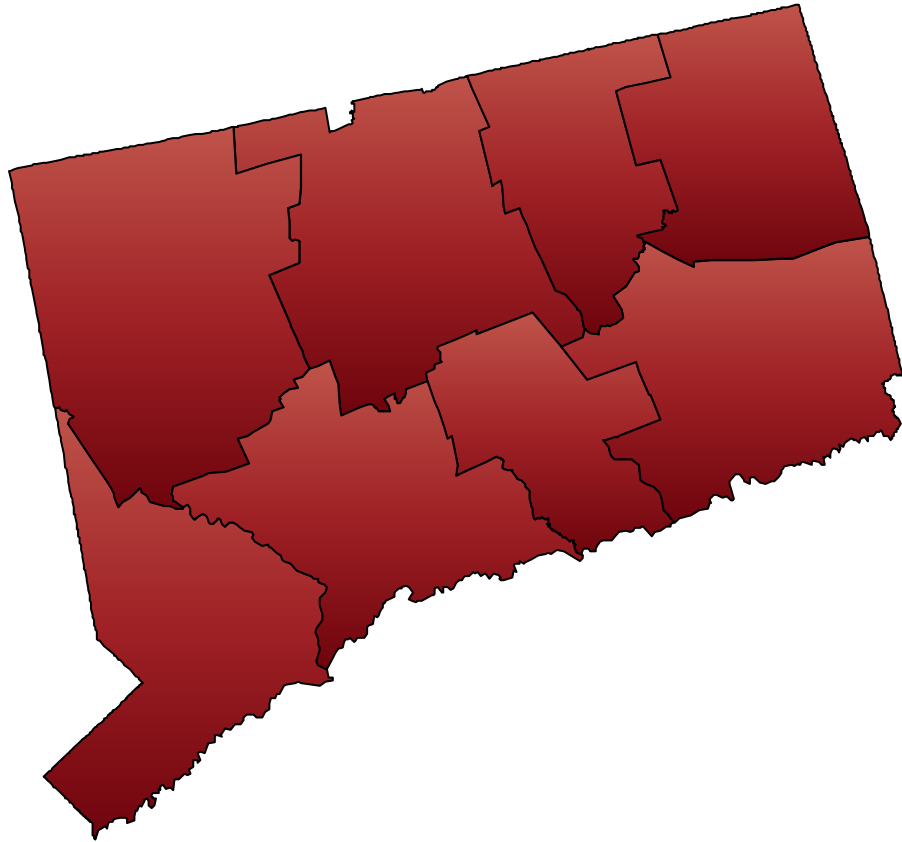

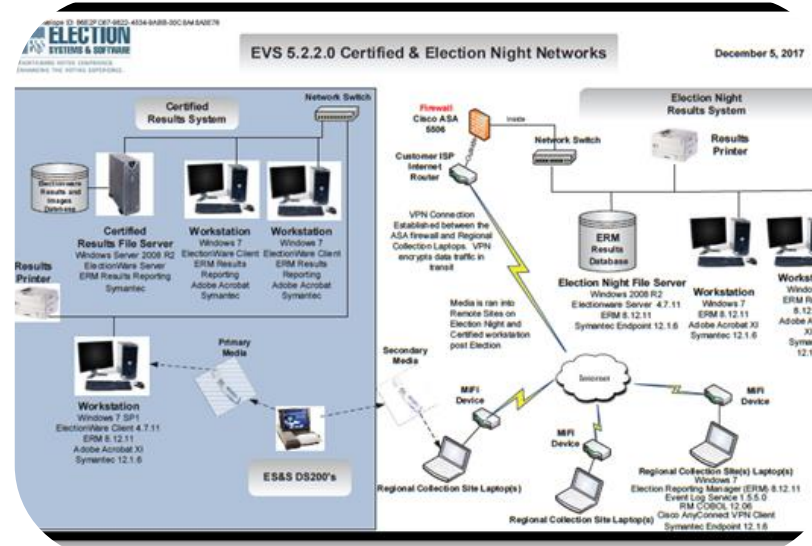

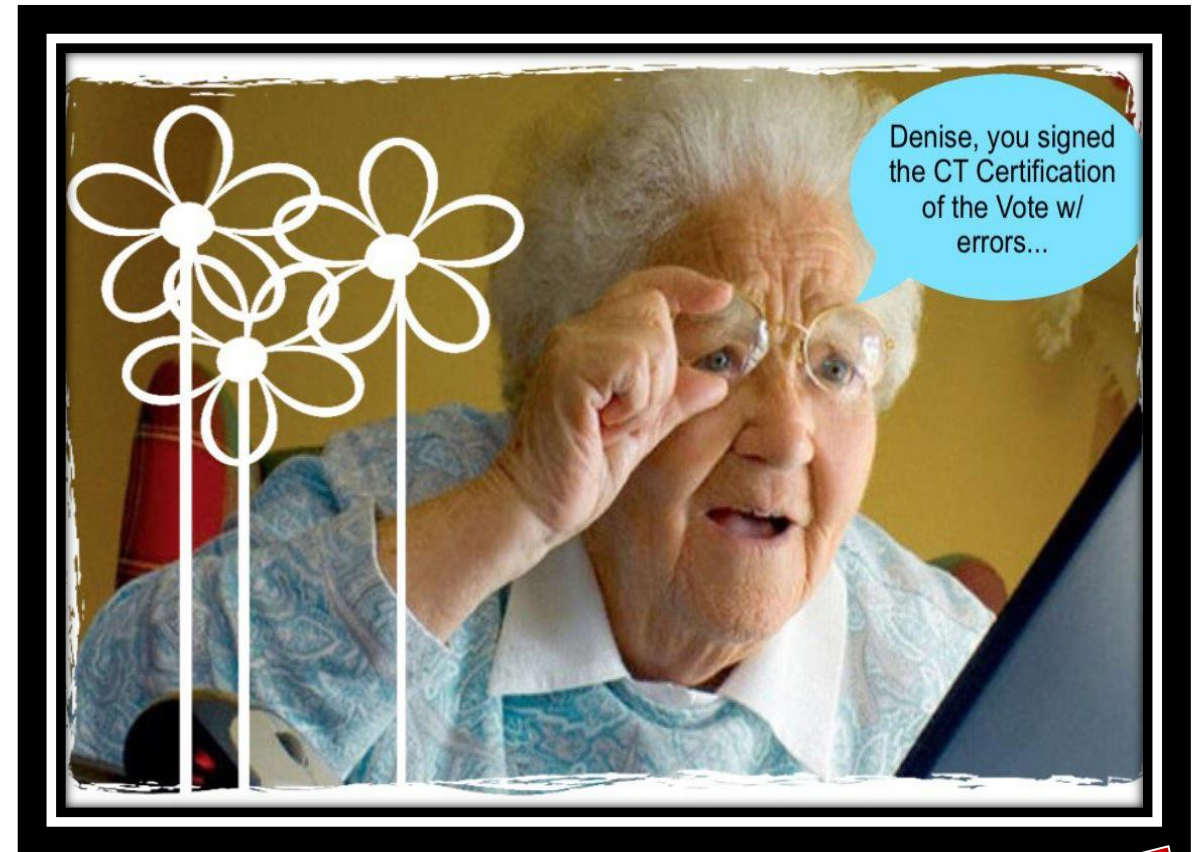


SOTS Office Tells Towns How Many People Voted

- 1. The Presidential vote totals do not add up on the State's 2020 final election report between:
 - Districts, Counties & Towns
- 2. Several towns report that the numbers on their town's Head Moderator Reports were required to be dictated to them by the Secretary of State's office
- 3. The certified Head Moderator Reports for some towns show they had been revised up to 5 times
- 4. ERIC owns all state communication records and calls them proprietary
- 5. Connecticut's LHS Machines do not produce a record that contains the selections produced by a single voter, as our tabulators are not capable of that function, so we have no records responsive to this request.
- CT has no sheriffs to use to push back on unconstitutional actions taken by politicians


